

Education has the power to transform lives

Education is one of the few things that can completely rewrite the social landscape. In our rapidly developing economy, education has emerged as a powerful tool that can utilise the immense potential of billions to fuel the growth of the nation. Education creates a plethora of opportunities that provide employment, improve the socio-economic situation and ensure a secure future. India faces a stiff challenge of improving standards of education, due to a significant quality deficit in this sector.

Crediting education as the foremost and strongest factor influencing change and improvement, we, at the Adani Foundation, have chosen to focus our efforts on bettering educational facilities for children. Our education initiatives include providing quality education to students in schools managed by the Foundation. We also support through scholarships and grants to the needy, career and vocational guidance, skill development programmes and support and assistance to government schools. We endeavour to provide children with equal educational opportunities, which can transform their lives.



Education is a powerful tool to create the possibilities for a child to invent and discover. It is not just to prepare a child for life, it is life itself. Through its education initiatives, the Adani Foundation works actively to ensure that children have access to quality education and skill acquisition.

Ahmedabad (Gujarat)

Adani Vidya Mandir, Ahmedabad (AVMA) – a Cut Above the Rest

Education propels a nation's progress. But this progress is only possible when every child's fundamental right to knowledge and learning is fulfilled. Directed towards this very goal, the implementation of the Adani Vidya Mandir is an exemplary initiative by the Adani Foundation. Today, this school has become a ray of hope in the lives of meritorious children coming from economically challenged sections of the society.

The Adani Vidya Mandir, Ahmedabad, started functioning in 2008 with just three classes.

Today, it has reached the zenith of its success with more than 1,000 students enrolled. Providing quality education completely free of cost, it is acknowledged as being one of its kind. It is a day boarding, CBSE affiliated, coeducational school offering classes from Std. 3 to 12 (Science and Commerce streams). Students are also provided with transportation, uniforms, textbooks, notebooks, breakfast, lunch and refreshments, all free of cost.

The school's curriculum is an embodiment of its mission, ensuring holistic development of students. A well-balanced combination of academic, cocurricular, extra-curricular and skill development activities ensures that the students graduate as competent, well-groomed, aware, have exposure to different areas, and can

secure meaningful employment for themselves while contributing to the nation's growth and progress. With state-of-the-art infrastructure and facilities, the school is a cut above the rest.

Academics

- A student of the school cleared GUJCET with 95.81 percentile and was selected in S.S.G Medical College of M.S. University, Baroda. Another student cleared JEE Advanced and got selected in NIT, SVP, Surat.
- Miss Shristi Bajoria qualified for the Vahani Scholarship for her higher studies on the





basis of her academic performance in CBSE board examinations, and after clearing the personal interview and group discussion rounds.

- Master Ishan Mithadia, Miss Priyanshi Parmar, Miss Pruthvi Rathod, Master Atish Karathia, Master Harsh Parmar, Miss Nisha Tewani and Master Shalin Chavda, of Std. 9, appeared in the National Means Merit Scholarship Examination 2016 and qualified for the yearly scholarship of Rs. 6,000 for two years.
- In the past year, the school has started a foundation course for selected students of Std. 8 and 9, aspiring to appear for JEE. Special coaching classes for GUJCET and NEET aspirants have also been organised.
- The school has tied up with 'Don't Memorise' (www.don'tmemorise.com), which creates captivating online educational videos, to make mathematics more interesting and easy to learn. These videos, mapped to the curriculum, are shown to the students during classroom learning sessions. Further, students are evaluated through online quizzes to ascertain whether their concepts are clear.
- Co-curricular Activities
- For the holistic development of the students, AVMA provides them with the opportunities to appear in various in-house and outside competitions as well as Olympiad Examinations of Mathematics, English, Cyber and Science.
- To instill collaborative skills among the students, the school has various clubs like the Readers' Club, Heritage Club, Eco Club, Health and Wellness Club. Swachhagraha Club is initiated so as to sensitise them in their duties and responsibilities towards a clean and green India.



• Extra-curricular Activities

- Master Arya Goswami, of Std. 12, received the Young Authors' Award. His story has been published in the book 'Pens of Fame'.
- To save birds from serious injuries from threads used in kite flying during Makar Sankranti, students participated in the Save Bird Campaign. They collected 636.625 kg of thread and donated it to an NGO, which earned them the second prize in Ahmedabad.
- Career guidance programmes and educational trips
 Extra a part of the school curriculum as they extend
 Iearning beyond the classrooms. Luminaries from various fields are invited to the school to enrich the children.

Extra-curricular Activities, AVM, Ahmedabad

- Under the International School Library Month, students read and reviewed books. They
 also exchanged bookmarks with students of Croatian schools.
- The school has started its own in-house weekly newsletter which is distributed to the students of Std. 3 to 5, every week. The aim is to make their parents aware of the various activities conducted in the school.

- Master Kushal Shah, of Std. 11, won the gold medal in the district-level Karate Championship organised by SGFI.

• Engagement Programmes for Staff

Workshops were organised on topics like Effective Teaching Skills, Communication, Time Management, Relax and Recharge as well as Learning How to Say No to keep the staff updated on the current teaching and learning practices. The teachers were also sent to various external workshops. The school has also appointed a counsellor to address behavioural and learning problems of the students.





Mundra (Gujarat)



Balwadi - Mundra - 3 year old Amina

Emanating confidence, singing nursery rhymes and narrating stories in English with ease, 3 year old Amina's transformation at the Mundra Balwadi, supported by the Adani Foundation, is as heart-warming as it is encouraging. From a fragile little girl who used to fall ill often, she is now a self-assured, healthy and bright child. The proud parents talk enthusiastically about her progress and thank the team of the Adani Foundation for giving their daughter wings to fly.

Adani Vidya Mandir, Bhadreshwar (AVMB) – a Bright Spot in Education

A unique Gujarati medium school, the Adani Vidya Mandir, Bhadreshwar, started in June 2012 in Bhadreshwar village of Mundra taluka. The objective behind setting up this school

was to provide free education to children from the fisherfolk communities as well as economically backward families. The children are groomed to go back to their families and communities and become agents of change. Special care is taken to provide high-quality education and for the overall development of students. The Adani Foundation also gives nutritious food to the students including lunch and snacks every day.

In the 2015-16, the school began offering classes from Std. 1 to 10 with a total strength of 395 students. At present, 137 students belong to the fisher-folk communities. The school has organised additional coaching for newly enrolled students. Remedial teaching for weaker students has also been started for

Mathematics and Science. In addition to education, the Foundation also focuses on the overall health of the students by holding co-curricular activities and sports related events. In the past academic year, Annual Sports Day celebration was held on January. 28, 2017. Further, a farewell was also organised recently to bid adieu to the students of Std. 10.



Improvement in the quality of services and a sound infrastructure has become an utmost necessity to build a strong foundation for higher education. The Adani Foundation at Mundra works tirelessly to meet this objective.

Adani Public School, Mundra (APSM)- Making Education available for all

Established in 2001, the Adani Public School, Mundra, is an English medium, CBSE affiliated, co-educational, day school. Today, the school has a strength of 1,500 students and offers both science and commerce streams at the senior secondary level. It also provides coaching to students aspiring to appear for JEE and other competitive examinations by expert faculty.

Competitive Examinations

For more and better future prospects, the school provides students with ample opportunities to take part in various competitive examinations. In the academic session 2016-17, around 1,106 students participated in various Olympiads conducted by ASSET, SOF and EDUHEAL Foundation. In the International Mathematics Olympiad, 20 students reached the second level. In the National Cyber Olympiad, 7 students reached the second level, and 6 of them bagged medals. In the International Company Secretary Olympiad, 3 students qualified for the third level.

Swachhagraha

During the past year, many initiatives were taken up in the school under the Swachhagraha programme. Each class was monitored for a month, at the end of which the Best Clean Class Award was declared. To ensure that food is not spilled in the class, the students were asked to bring napkins and place their lunch boxes on them. They also prepared and personally gifted 'Thank You Cards' to the housekeeping staff. They made a 'Swachhagraha Wall' on which information and photographs were displayed. A team of teachers and student volunteers kept watch on the maintenance of the washrooms.







Co-curricular & Extra-curricular Activities

Students participated in the Youth Parliament. The school conducted career guidance programmes for students of secondary and senior secondary classes. Every year, since 2011, students of Std. 10 do a project under the guidance of Social Science teachers to raise funds for charity. This year the students raised an amount of Rs. 19,570 which was used in purchasing 181 blankets for distribution amongst poor people in Mundra.

Sports

- It was a proud moment for the school when Miss Megha Jain, Miss Vishakha Bhavsar and Miss Moksha Sharma were selected for the national-level throw ball competition. As a part of the Gujarat Throw ball Team, they will represent the state.
- Three girls and three boys got selected for the state-level ball badminton tournament.
- In the Khel Mahakumbh's district-level table tennis competition, Master Yash Patel secured the third position in the U-14 singles category while Master Saim Khoja and Master Udit Chavda secured the first position in the U-17 doubles category.

In the district-level athletics competition, Miss Moksha Sharma secured the first position in the U-14 discus throw event, second position in 80 m hurdles event and third position in the shot put event. Miss Pragati Jadav won the first position in 400 m race. In the U-17 category, Master Raj Thakrar got the first position in the long jump event and second position in the 200 m race. In the U-19 category, Master Jay Singh achieved the second position in the 110 m hurdles event and third position in the discus throw event. Miss Harshida Bajaria got the third position in the 400 m race while Miss Kamini Chauhan secured the second position in shot put event.

Workshops for Staff and Students

Workshops on topics of Self-awareness, Mathematics and 'Five S' were conducted for the benefit of the students. Also, Sambodhan– a workshop for Hindi teachers, another workshop for pre-primary teachers, the Microsoft Teacher Ambassador Programme and a four-day workshop for teachers on modern pedagogies were also conducted in the school.

Material Support – Furnishing Education

The Adani Foundation constructed a science laboratory and provided furniture support to the Science School, Mundra. Furniture support was also given to the Block Resource Center, Mundra. The Foundation supported a district-level annual event at the Kasturba

Gandhi Kanya Vidyalaya. In addition to this, a sound system was given to the primary schools of Siracha, Tunda Wandh and Vallabh Vidyalaya.

Shala Praveshotsav – Encouraging Students

In order to motivate children to attend schools, the Adani Foundation provided education kits to welcome 2,500 newly enrolled students from 111 government primary schools in 61 villages of Mundra taluka.

Adani Education Development Centre – Extra Support for Improvement

As per government figures, only 10 schools of Mundra taluka, from amongst a total of 103 schools, fall in the A grade. Therefore, in a quest to improve this dire situation, the Adani Foundation has initiated a coaching centre at Zarpara which is already producing good results. Out of 62 students falling in D grade, 58 have improved immensely. From these, 8 students are now in C grade, 30 in B grade and 20 have reached A grade. For the upcoming year, plans have been made to start another centre at the Navinal village.

Hazira (Gujarat)



Navchetan Vidyalaya, Junagam, Hazira-Drashti Sanjaybhai Tailor

From an average student when she joined in 2014-15 to scoring 92.88% in the exams of 2016-17, Drashti Sanjaybhai Tailor, a class 5 student, in Navchetan Vidyalaya, Junagam is an exemplary performer. She just needed a slight push and a little motivation to realize the spark that the teachers could see in her. Her parents are very thankful to the Adani Foundation for her progress.





Navchetan Vidyalaya, Junagam – Lighting the Path Towards Education

Established in 2003, the objective of the Navchetan Vidyalaya, Junagam, is to provide quality education to children coming from rural areas. Today, the school has made a mark for itself in this region with 304 enrolments and an equal number of boys and girls. The school is equipped with smart classrooms and a sports ground in the school campus. The pedagogy includes handwriting improvement classes, unit tests at regular intervals, spoken English classes, activity-based teaching, regular parent-teacher interactions and special attention to slow learners. In addition to this, the school provides food and academic material support such as uniforms, notebooks, workbooks, textbooks and stationery to the students for free.

With an aim to inculcate basic concepts of Mathematics, Science and Technology at the school level, Navchetan Vidyalaya has tied up with STEM Learning and developed a Mini Science Centre in the school. This centre has a range of 60 odd tabletop working models with backdrops and manuals in the local language to provide a hands-on learning experience for students Std 5 to 8.

The school also provides training and exposure to teachers on the utilisation of smart classrooms, scientific teaching methodologies and effective communication skills. In the past academic session, the kindergarten playground has been developed and equipment such as a see-saw, merry-go-round, swing set, slide, etc. has been added to it.

Strengthening the Pragna Project – for Better Learning Outcomes

The Adani Foundation has extended support in strengthening the Pragna Project in Hazira, Gujarat. The Pragna Project is a government initiative under the Sarva Shiksha Abhiyan. It promotes activity-based learning through numerous activities, field work and project work. The active and continuous participation of students ensures better learning outcomes.





Teacher's Training Workshop on 'Learning: The Treasure Within'

The Adani Foundation, in collaboration with Jeevantirth and with the active involvement of the Government Education Department, organised a one-day workshop on 'Learning: The treasure within'. The recommendations of the State Level Committee on 'Gunotsav' were also discussed during this workshop. The objective behind these activities is to create a new methodology and programme for the lower primary education system. Based on the principle of constructing knowledge, this programme will ensure the development of basic literacy and mathematical abilities among children coming from rural areas.

Anganwadi Support Programme- Improving Learning Environment

In the field of education, the Adani Foundation is working for 52 Anganwadis from 15 villages in Hazira, Surat district. It takes measures to support the government's ICDS programme, provide a child-friendly environment and improve children's interest in learning.

Material Support to Needy Children- In Pursuit of Education

Through its various activities, the Adani Foundation identifies needy, orphaned or single parent children from the nearby villages. These children are provided with material support such as school bags, books, notebooks, etc. to help them in pursuing their education.

Surat Science Centre Visit-Encouraging Interest In Science

With the objective of developing an interest towards Science and Mathematics among the students, an exposure visit to the Surat Science Centre was organised. Students of Std. 7 & 8, of four primary schools in three villages of Hazira, were taken on this visit.

Dahej (Gujarat)

After discussions with school authorities and local leaders from nearby villages, the Adani Foundation in Dahej has taken up several initiatives for improving education scenario in these villages.

- As material support to the Pragna Project, the Foundation distributed basic stationery to 3,600 students spread across eight schools.
- An exposure visit to Science City and Akshardham has directly benefited 92 students from eight different schools.
- The aim of BALA Project is to create a fun-filled and interactive learning environment. Under this project, murals and educational paintings were done on the walls of two village schools and 13 Anganwadis benefiting 4,000 students.
- School kits were provided to 290 children from eight schools in the Dahej cluster under the Praveshotsav programme. The objective was to motivate children to attend school. This also helps in curtailing the financial burden upon the parents up to some extent.



 Sports equipment was offered to schools, under the Sports Material Support Programme. This initiative, benefiting 3,600 students from eight different schools, was carried out for improving sports and physical education.

Tirora (Maharashtra)

Adani Vidyalaya, Tirora (AVT) – Earning a Strong Reputation in Education

With an enrolment of just 30 students, the Adani Vidyalaya, Tirora, was started in 2014. Today, it has 117 students. Over the past three years, the school has grown considerably and



caters to the children of Adani employees as well as from the surrounding communities. The school has developed a strong reputation as an educational institution focused on quality teaching and learning. Every year, it conducts a number of curricular and cocurricular activities as well as different exhibitions for the overall development of students. This year, a language exhibition was organised to enhance the students' creativity. As part of teachers' enhancement programme, a two-day workshop on Maths through Origami and a one-day workshop on Handwriting Development Skills were organised.

Other Activities- Further Education Through Different Ways

- The Adani Foundation in Tirora has started coaching classes on a regular basis for students aspiring to gain admission into the Jawahar Navodaya Vidyalayas.
- The Foundation has become a state-level partner with the Education Department of the Maharashtra Government for a capacity-building campaign. Around 600 senior, middle and junior level government officers have undergone training for this programme.
- A software and online & offline apps have been developed by the Foundation with the support of the Maharashtra Government. These apps are designed to impart knowledge to Anganwadi students in an audio-visual manner. The government is planning to replicate this project in other Anganwadis of the state.
- E-Learning kits were distributed to 44 government schools and training for using the kits was also given.
- In order to motivate and support high school students in planning their future, a one-day workshop, teaching goal setting and offering career counselling, was organised in four high schools wherein more than 1,100 students participated.
- With the objective of spreading awareness about road safety, the Adani Security team,







along with the Adani Foundation team, conducted a mass awareness rally in Tirora. Over 1,000 students from the vicinity area participated in this rally. An on-the-spot road safety quiz was also organised, and the winners were awarded. Furthermore, the students performed a motivational skit and delivered speeches on road safety awareness.

- Support was extended to high school and junior college students preparing for JEE, PMT, PET, CA, etc. by distributing books to them. Around 56 students of the region benefited from this.
- Sports material was also distributed to youth preparing for the entrance exams of Railways, Police Department, etc.
- To enhance the quality of education in the nearby schools, employees of the Adani Group at Tirora, have volunteered to spare two hours every week for teaching Mathematics, English and Science to school students. So far, more than 45 employees have participated in this noble cause.

Kawai (Rajasthan)

Adani Vidyalaya, Kawai (AVK) – Providing Quality Education

Established in 2014, the Adani Vidyalaya, Kawai, was started with the objective of imparting quality education to the children of the township. Despite the remote location of the school, the teachers are provided with regular enrichment programmes for improving standards of teaching. Students are also exposed to a myriad of co-curricular and extra-curricular activities for their holistic development. In the past academic year,





four training sessions were organised for the teachers while several awareness programmes such as Cleanliness Drive, International Yoga Day, Drawing competition on fire & safety, Celebration of Road Safety Week, etc. were conducted for students.

Other Activities Conducted Under Education Initiatives

- The Adani Foundation in Kawai has adopted 47 government schools with the aim of contributing towards developing their basic infrastructure. Due to the lack of toilet and urinal facilities in schools, the students, especially girls, suffer a lot and it affects their presence too. Hence, the Foundation has constructed toilets & urinals in schools including the Upper Primary School at Mukundpura.
- Under the Prayatna initiative, 111 students from 24 schools in the region have been provided with study kits. Coaching classes for Jawahar Navodaya Vidyalaya (JNV) Entrance Examination have also been conducted.
- Extra classes were organised at the labour colony for students of primary classes to help them in academics and sports while building cultural and moral values in them. Nutritious food, uniforms and winter wear were also provided to these children.
- The Adani Foundation has provided support to the Zilla Parishad of Baran in developing the Happy School Management Android app. This app is used for proper management & monitoring of government schools and the education department of the state.
- The Foundation's team in Kawai organised 5S training for teachers and students in government schools. Around, 300 participants benefited from this training.
- Around 120 students from Std. 11 and 12 received career guidance through the Disha Project and its various activities.
- Equipment for science lab was provided to the Senior Secondary School, Kawai, which benefited 632 students of the school.





- Solar lamps were distributed to the 1,100 senior class students to use while studying in the dark.
- Sports tracksuits were provided to 1,825 players who got selected for state-level competitions.
- With the aim of providing cool drinking water to students during summer, the Adani Foundation gave water coolers to schools. Around 2,231 students of the Senior Secondary schools benefited from this gesture.
- For promoting rural sports, the Foundation has extended financial support to local tournaments.

Surguja (Chhattisgarh)

Adani Vidya Mandir, Surguja (AVMS) – Turning into a Landmark School

The Adani Vidya Mandir, Surguja, was established in 2013 to provide quality education to the students of nearby villages from an underprivileged background. The school was initially started in the Salhi Panchayat, Bhawan, premises with a handful of students. Today, the number of students from Jr. KG to Std. 8 has reached 570. In the past year, a state-of-the-art G+2 building with 23 modern classrooms and a built-up area of 3,783 m² across a campus of 3.86 acres was constructed. This building has three laboratories for science, mathematics and computers, a fully equipped library, an audiovisual room as well as facilities for sports, music, dance, art and craft. The school provides completely free of cost education to the students which includes meals, textbooks, stationery, uniforms and transportation. A judicious blend of curricular and co-curricular activities forms part of the pedagogy for ensuring holistic development of the children. For enhancing teachers'

competency and motivation, regular training programmes and workshops by outside experts as well as in-house knowledge sharing sessions are conducted.

> This year a Mini Science Centre has been created in school with the help of STEM Education to generate awareness about the value of learning science among the children and teachers. The centre has a range of 60 tabletop working models with backdrops and manuals in the local language to provide a hands-on learning experience in science and mathematics for students Std 5 to 10.

Co-curricular Activities, AVM, Surguja

Project Digital Gram – Training in Cashless Transaction

This project was conceptualised to contribute towards the national goal of Digital India. It is designed to make rural youth and school students computer literate. It also imparts training necessary for cashless transactions at the village level.

Adani Enterprises Limited (AEL) took up initiatives to establish computer literacy centres in villages of Salhi, Parsa, Basen and Ghatbarra after consultation with the District Administration through the Sub-Divisional Magistrate (SDM), Udaipur Janpad with a Public Private Partnership

Approach. Accordingly, the centres have been opened in these four villages in collaboration with the Gram Panchayats.

Under Project Digital Gram, a training on cashless transactions was organised on January 10 & 11, 2017 for the villagers of Fatehpur and Salhi at the Adani Rural Resource Centre, Basen. On facilitation of the SDM, Udaipur Janpad, Mr. Sampuran Rai imparted training on behalf of the Janpad Administration while Mr. I.K. Rai from AEL complemented the training. Around 56 people underwent the training and learnt various modes of cashless transactions like PAYTM, debit cards, credit cards, etc. Out of these, 33 people including 10 women of Fatehpur village and 23 people including 10 women of Salhi village participated in this training.

Adani Inter-village Sports Tournament 2016

This tournament was inaugurated on August 30, 2016, in which six youth clubs participated in three events – Kabaddi, Volleyball and Tug of War.

Inter-village Football Tournament 2017

This tournament was held at Parsa Sports Ground in which eight youth clubs of Salhi, Parsa, Basen, Hariharpur, Ghatbarra, Kente, Shivnagar and Fatehpur participated. About 500 rural spectators witnessed the final match.

Dhamra (Odisha)

Adani DAV Public School, Dhamra – an International Standard School

The Adani Foundation has constructed a state-of-the-art school by the name of Adani DAV Public School at Kuamara, around 17 kms from the Dhamra Port. The school's G+2 building





has a built-up area of 3,501 m² spread across a campus of more than 5 acres. The building has 16 modern classrooms, two libraries for junior and senior class students respectively, separate laboratories for Physics, Chemistry and Biology, and two for computers, an audio-visual room. It also has facilities for sports, music, dance, art and craft. An MoU has been signed between the Adani Foundation and the DAV College Trust and Management Society to run this international standard school.

Initially, the school was established in 2012 under the name DPCL DAV Public School, Dhamra, and it was located at the Dhamra Port complex. Adani Ports and Special Economic Zone Limited (APSEZL) took 100% ownership of the school from the erstwhile management on June 23, 2014. Since then, it is running the school in collaboration with the DAV College Trust and Management Society with 100% financial support.

Rural Knowledge Centre – Computer Training and Personality Development

Situated adjacent to the Port Gate, the Rural Knowledge Centre has started running with eight students from the nearby villages and two computer trainers. At this centre, the students are provided with basic computer skills of MS-Office. The aim is to train rural students in information technology as well as personality development, spoken English, etc. to match with the present scenario of globalisation.

Support to Schools - Bringing a Positive Change in Education

Rural Knowledge Centre, Dhamra

RURAL KNOWLEDGE CENTER

The Adani Foundation, being the CSR arm of the Adani Group, provides rural schools and students with different kinds of support such as providing benches, desks, science lab equipment, school uniforms, school bags, study materials, etc. In the past year, six schools have been provided with 90 benches & desks and four schools were given science lab equipment support. Furthermore, the CSR team will be setting up kitchen gardens, provide utensils as Mid-Day Meal support, school bags, uniforms as well as e-learning facilities in the schools to bring a change in the current educational scenario in Odisha. The Foundation's activities have covered 10 schools and 5,000 students.

Merit Scholarship- Monthly Assistance for New Innings

The Adani Foundation started providing Merit Scholarships since 2009 to the students who secured 75% marks or more in the matriculation examination. To boost up their spirits and enable them in pursuing higher education, these students have been given a monthly assistance of Rs. 1,000 for two consecutive years. In the past year, 23 students of nine high schools from eight peripheral Gram Panchayats received these scholarships.

Awareness Programmes in Schools on Societal and Environmental Issues

The Adani Foundation at Dhamra Port conducted various awareness programmes in rural schools targeting approximately 2,500 students. These programmes covered different social and environmental issues such as health, basic hygiene, menstrual hygiene of adolescent girls, environment, sanitation, water management, conservation of marine turtle, etc.

Adani Dhamra Port Volleyball Tournament

The Adani Foundation with the help of the CSR team organised the Adani Dhamra Port Volleyball Tournament on December 20 & 21 at the Dosinga Market ground. The nine day long tournament saw enthusiastic participation from 10 teams of eight Panchayats, namely Dosinga, Dhamra, Jagula, Karanapalli, Bansada, Kaithakhola, Panchutikri and Karanjamal. The teams were provided with jerseys, tracksuits, volleyballs and volleyball nets.

The final match was a close one between the teams of Dosinga and Amarnagar with the former emerging as the winner. The winning team was presented with a trophy and cash prize of Rs. 10,000 while the runner-up team was presented with a trophy and cash prize of Rs. 8,000. Attended by local PRI members, the match pulled huge crowds of youth and villagers, all of whom were present to encourage nearly hundred players from different Panchayats.

Adani Inter-school Girls Athletic Meet

The Adani-Dhamra Port, with the efforts of the CSR team and involvement of schools and communities, organised the Adani Inter-school Girls Athletic Meet 2017 on February 7, 2017, at the Dosinga ground. Girls of the following nine high schools of eight Panchayats participated in the meet.

The schools were informed about the athletic event, and the players were segregated accordingly. The CEO of Dhamra Port, Shri Subrat Tripathy, CSR Head, Shri Prabhat Kumar Mishra, Headmaster of Dosinga High School, Mr. Sukumar Jena, headmasters of other







schools, PET teachers and the CSR team were present for the day. At the end of the meet, the students performed a dance and showcased their talent. The active participation of the students and teachers made the day successful.

Adani Inter-school Girls Kabbadi Tournament

The Adani-Dhamra Port, with the efforts of the CSR team and support of Dolosahi school management, organised the Adani Inter-school Girls Kabaddi Tournament 2017 on February 9, 2017, at the Ramnarayan High School Dolosahi, Bhadrak. Students from the following eight high schools of seven Panchayats participated in the tournament.

The schools were informed about the tournament and had prepared accordingly. Nearly hundred students from periphery areas participated in the tournament and made it successful. Many individuals were motivated by this programme. R.N. High School won the tournament beating Achak High School by 22-19.

Adani Inter-School Girls Kabaddi Tournament, Bhadrak

The Bhadrak District Sports Officer graced the closing ceremony and honoured the winning team by giving them certificates.

Adani-KISS Residential School- for the Upliftment of the Tribal Community

The Adani Foundation has signed an MoU with the Kalinga Institute of Social Sciences (KISS) for setting up a residential school (from Std. 1 to 10) in the Baripada, Mayurbhanj District in Odisha. The aim of setting up this school is to provide quality education free of cost to underprivileged children belonging to socio-economically backward sections of the tribal commuity with a special emphasis on the girl child. The Adani Foundation has already released the first instalment of funds to KISS for the first phase of infrastructure development. The school is expected to be operational from 2018 session.

Udupi (Karnataka)

Education is an act towards empowerment and plays a vital role in creating the future of our children. In the field of education, Adani UPCL is targeting schools, located in and around its plant in Udupi District, as well as students, residing in the vicinity, through its activities.

Education Kits – Supporting the Quest for Education

UPCL, in association with the Adani Foundation, has distributed quality education kits containing branded slates, notebooks, bags, geometry boxes and umbrellas to students of

Kannada medium government & government-aided schools in the Udupi district. This initiative was undertaken to promote education among needy students, from poor backgrounds in the rural areas, and it has already helped in increasing the strength of students in these schools.

School Development Grant - Need-based Initiatives

In 2016-17, UPCL provided two desktop computers to CSI School, Muloor, and facilitated the teachers so they can impart computer education to the students. Such measures are undertaken after a thorough understanding of the needs of government and government-aided schools.

Education Kits, Udupi

Scholarships – Rewarding Diligent Efforts

To motivate the children in pursuing their studies, UPCL, in collaboration with the Adani Foundation, distributes scholarships to the top two scorers in each class from Std. 5 to 9. The schools covered under this initiative are all government and government-aided Kannada schools located in the vicinity of the plant.







• For Students from Std. 5 to 9

For the student who stands first, the scholarship amount is Rs. 2,750, while for the student who stands second, it is Rs. 1,750. In the past year, 310 students from 68 government schools benefited in this category, and a total amount of Rs. 7.04 lakh was used under scholarships.

• For Students from Std. 10 onwards

Apna School Initiative, Godda

Scholarship were also awarded to students residing in the plant vicinity, who have passed SSC, pre-university, graduation, post-graduation, diploma, engineering, medical, nursing, paramedical or other professional courses and have scored 70% and above. In this category, the scholarship amount varies from Rs. 3,750 to Rs. 10,000 depending on the discipline or branch of study. In the past year, a total amount of Rs. 67.96 lakh was awarded and 1,572 students benefitted under the scholarship scheme.



Apna School Initiative – Building a Strong Foundation for Learning

In the tribal villages of Nayabad, Gangta and Petbi, the Adani Foundation provides coaching classes to students till Std. 5. In all, 63 tribal children benefited from this initiative which has had a positive impact on community connect.





Haath Dhoyein Swastha Rakhein - Inculcating Clean Habits

Under this initiative, demonstration programmes were held before Mid Day Meals to promote sanitary and hygienic habits among 1,200 school going children in 10 primary and middle schools.

Talent Hunt Programme – Recognising Skills in Students

A talent hunt programme comprising of a drawing competition on the theme of Swacchata Abhiyan as well as athletics and cultural events, to encourage local talent, was organised in Motia on the eve of Independence Day. More than 2,000 students participated in this programme. The drawing competition was particularly interesting. Local leaders including Mukhiya and Panchayat Samiti members were present on the occasion.

Survey of Schools- Understanding Infrastructure Needs

A survey of schools was conducted to assess infrastructure available to students and the conditions of learning for facilitating future interventions. Twenty-one Youth Clubs,

consisting of 250 youths, were formed in projectaffected villages for engaging them in different productive activities.

Sports Initiatives- Ensuring Overall Development

- The Adani Foundation distributed sports kits comprising of footballs, volleyballs, cricket equipment, carrom boards, ropes and discs to 11 schools and youth groups in the periphery villages.
- Support was extended to the District Netball Association for distribution of prizes and shield in the

District Netball Tournament. The local MLA of Godda inaugurated the programme.

- The Foundation also organised a two-day volleyball tournament on the Motia High School ground in which teams from various villages participated.
- Support was also provided for the annual fair organised by the tribal community on the occasion of the death anniversary of martyr Tilkha Manjhi. This fair is being organised since the last 26 years. On the eve of the fair, a football tournament was organised along with a lot of other games which saw participation from more than 2,000 people of the tribal communities of various villages in the district.

Winter Wear Distribution-Spreading Warmth

Winter wear was distributed to approximately 2,600 school children up to Std. 5 including Anganwadi children.

Quiz Competition and Felicitation of Teachers

On the eve of Saraswati Puja, a quiz competition was organised for children at Basantpur. A felicitation programme for superannuated teachers was also held on the same day. A total of 16 teachers were felicitated.

Road Safety Week – Education and Awareness

The Road Safety Week was organised in collaboration with the Police Department and the Nagar Panchayat. During the week, various IEC materials were used on the roads. In the concluding programme, students from various schools participated in a rally.

Vizhinjam (Kerala)

The Adani Foundation provided the following equipment to nine government schools of the region:

- A biogas unit with a capacity to treat 5 to 7 kg of waste, emerging from the mid-day meals, was given.
- Water purifiers, with a capacity to purify 7 to 10 L of water at a time and a separate container with a tap to collect purified water, were given to each school.
- Bookshelves, made of wood with full glass doors, were provided.
- Lab support including microscopes, science kits, math kits and other basic apparatus was given.

Merit scholarships of Rs. 10,000 per year were awarded to select 25 students for a period of two years.

Community Health

Good health is the tool that transforms lives

As the economy of a country improves, so does the health of its citizens. However, the opposite is also equally true - improving the health of a nation's citizens can directly result in economic growth; because there will be more people able to conduct effective activities in the nation's workforce. Health plays a crucial role in transforming people's lives. Healthy people can utilise opportunities available to them. A well-configured and highly resourced healthcare system is required to provide basic health services to the people. Today, the foremost challenge confronting India is improving its health indicators.

At the Adani Foundation, we have committed ourselves to raising the standards of and strengthening healthcare systems in India. Our need-based projects are designed to ensure accessible, affordable and effective health services for all sections of the society. We implement programmes like health cards for senior citizens, health-related workshops, de-addiction campaigns, health and sanitation awareness programmes, school health check-ups, specialised health camps, etc. Through our efforts in community healthcare, we aim to create a society where the right opportunities will transform lives for the better.

Community Health

Health inequities tend to be extremely oppressive and negatively impact development. For the underprivileged, the Adani Foundation takes measures to counter their inability and create conditions assuring the health and well-being of their families.

The Adani Foundation has made Community Health one of its main focus areas. It works with the humble objectives of providing access to basic healthcare and implementing innovative need-based projects. All of its initiatives are geared towards bridging the gaps and health enhancing behaviour leading to healthy living and a better quality of life. One of these initiatives is the Mobile Health Care Unit (MHCU) that reaches out to all remote rural locations which are not covered by government services. The MHCUs provide basic healthcare services like diagnostics, medicines, free of cost referrals, reliable punctuality and services by certified doctors at the doorstep. The social returns, on this investment, are much higher as patients save money on consultation fees, medicines and travel costs (of patients and the accompanying person). Loss of livelihood due to lengthy treatment and emotional stresses are also avoided. Due to the MHCU's services patients can avoid further medical complications and resultant expenses too. The Health Card to Senior Citizens at Mundra and Sanjiwani-W project at Surguja are examples of need-based innovative projects.

Mundra (Gujarat)

GAIMS - Assistance for Everyone

The Gujarat Adani Institute of Medical Sciences (GAIMS) is a unique public-private partnership between the Adani Education and Research Foundation and the Government of Gujarat. GAIMS came into existence in 2009 as a much-needed medical college approved for Kutch district. The college enrols 150 students for the MBBS course every year and thus, it has a total strength of 750 students. It also has 28 seats for post graduate courses in different pre-clinical and clinical branches. The G.K. General Hospital

GAIMS, Mundra

has been converted into a hospital with a capacity of 700 beds. The presence of the Adani Foundation's team in the reception area is a comforting support to patients and relatives in this huge hospital building.

The Foundation has also introduced various initiatives to cater to patients from remote areas. Multi-specialty medical camps, awareness camps and more than 290 meetings at the village level have made a big difference to the health scenario in the Kutch district. These initiatives also included health check-ups in around 40 schools benefiting more than 7,500 students.





Health Card to Senior Citizens – Support in Old Age

This project, addresses a special need in Mundra where the younger population migrates for better livelihood opportunities and the elders stay behind. The aim of this initiative is to provide hassle-free healthcare services to the elderly and promote awareness for preventive healthcare, healthy living and healthcare seeking behaviour amongst senior citizens. The Health Card also enables the elderly who do not have anyone to take care of them to receive timely and appropriate health care.



After an initial three-year pilot programme, the socio-economic Health Card to Sr. Citizer parameter was added. Currently, 6,665 green card holders, with a

family income of less than two lakh per annum, can avail free services amounting to 50,000/- for three years. Also, senior citizens' families whose income is more than two lakh per annum are given blue cards allowing them to get healthcare services at the Adani Hospital at subsidised rates.

Adani Foundation Senior Citizen Scheme, Mundra

Nostalgia and a healthy glow looms large on her face as 70 year old Ameena ben talks of the stories of her youth. In the absence of her life partner, and three sons who were away trying to make ends meet, she found a strong support system in her healthcare providers at the Adani Hospital. Suffering from high blood pressure, myriad stomach ailments, and severe anxiety, Adani Foundation's Senior Citizen's Health Card at Mundra and an efficient team of medical professionals administering her with the right medicines and periodic check-ups, restored her health and so did her desire to live.

Sr. Citizen Scheme, Mundra

Dignity to Death – a Humanitarian Gesture

This is another initiative, by the Foundation, through which the dead body of a person is transported to his/her native village if the death occurs at GAIMS. Till date, 584 families have been relieved of the worry about travel costs in taking deceased loved ones back home.

Other Activities – for the Health of the Community

The entire region of Kutch is sparsely populated. This creates a lot of hardships for the

communities when reaching out for basic healthcare facilities. The Foundation runs 11 rural clinics catering to 11 villages and two MHCUs which cover 29 villages and 6 fisherfolk settlements near Mundra and 8 villages near Bitta. These highly-appreciated services have provided free of cost treatment to 87,665 people at their doorsteps.

Medical camps at 14 doorstep locations have served 1,568 patients. The Foundation's medical officers conduct awareness sessions on preventive healthcare at schools and colleges covering 1,300 students. Besides this, five patients from socio-economically backward backgrounds are being supported with regular bi-weekly dialysis and 18 differently-abled people with regular physiotherapy services. More than 1,400 deprived community members have also got medical aid.

Hazira (Gujarat)

The Adani Foundation in association with the Port Health and Safety Department organised a series of general health check-up and eye check-up camps for truck drivers and assistants. More than 500 truckers received consultations as well as free medicine. This kind of support carries great value as truckers spend more time on the road and end up neglecting their health. This has an adverse impact on not just themselves and their families but also on their work and others on the road.

The communities near Hazira site has expressed a need for support in a de-addiction and rehabilitation campaign.

A process driven approach, starting from general awareness

General Medical Camp, Hazira

campaigns, has lead to addicts and their families coming forward for rehabilitation, referral and treatment at the centre. Close follow-ups with constant support by the families have resulted in reviving the corroded family structure of five households in the vicinity.

Dahej (Gujarat)

At Dahej, the MHCU service is operational since 2014. It covers 12 villages in the vicinity of the Adani Petronet (Dahej) Port Pvt. Ltd. During this year, the MHCUs have benefited local communities by providing treatments to 21,677 people.

Considering the disease patterns and need for referrals, multi-speciality medical camps







were organised at two locations with the services of a gynaecologist, orthopaedic surgeon, heart specialist, skin specialist, paediatrician, eye & ENT surgeons. Free of cost follow-up services were established, and huge discounts were negotiated in the cases which required surgeries. More than 525 patients benefited from these special health camps.

Health is closely associated with the hygiene and sanitation status of the communities. The Foundation conducts hygiene and sanitation awareness drives with Anganwadi and school children and adolescent girls. These campaigns directly benefited more than 4,000 students from 11 schools and 13 Anganwadis.

Tirora (Maharashtra)

There are only four PHCs (Primary Health Centres) and one Sub-District Hospital catering to 114 villages in the Tirora taluka. The perfect opportunity to bridging this gap was the initiation of Medical Health Care Unit (MHCU) services. The MHCU provided 44,847 free treatments during the year. In March 2017 one more MHCU was added, and now, the Foundations' two MHCUs will cover 50 locations in 45 villages.

The Foundation has been working closely with the Sub-District Hospital in Tirora for its upgradation which will benefit the general population. At this hospital, ICU, OPD areas, drinking water & sanitation facilities and

surrounding areas were renovated and upgraded with civil work, material support like furniture and equipment, necessary repairs and horticulture work, etc. Employees of Adani Power Maharashtra Limited, under the leadership of the station head, took a keen interest and supported this work. The '5S' methodology (sort, set in order, shine, standardise and sustain) was introduced for long-term sustainable results. This support has helped the Foundation in receiving the 'Kayakalp Award' in the state category from the Government of India. It has also resulted in a 30-32% increase in the number of people utilising the outpatient and inpatient facilities.

Magic Pit, Tirora

An innovative yet very simple solution to numerous issues of health and sanitation was introduced to the local communities through a workshop on 'Magic Pit'. Low in installation and operating costs, the Magic Pit helps in supporting recharging of water and eliminates the nuisance of open drainage and mosquito breeding.

Kawai (Rajasthan)

Medical Health Care Units (MHCUs), with their regular visits, have provided treatment to 35,500 people in 28 villages. Besides free consultancy and medicine at the doorstep, their services also extend to visiting the homes of weak and elderly patients, referrals and follow-ups, health check-ups of school children as well as general awareness for prevention of diseases, especially seasonal ones.







Multi-specialty medical camps were organised in two clusters with services from a gynaecologist, skin specialist, paediatrician, physician, ophthalmic surgeon and dentist benefiting 544 patients.

The Adani Foundation has signed a five-year MoU with the Government of Rajasthan for the adoption of Community and Primary Health Centres in 2012-13. Under this programme, the Foundation has supported renovation and upgradation of the Malnutrition Treatment Centre. This has resulted in better utilisation of the facility and has been very beneficial for the SuPoshan project.

Project Sanjiwani-W, Surguja



Surguja (Chhattisgarh)

The Adani Foundation in Surguja reaches out to the communities with various initiatives which are carefully planned after understanding needs of the people. Through its flagship programme, Sanjiwani-W, it aims to reduce maternal and infant mortality. It also aims to create awareness about various health related issues and change in attitudes towards health. For this initiative, Sanjiwani workers underwent six training sessions.

MHCU, Surguja

Mobile Health Care Unit, Shyampur, Surguja

Post an incident that left him with acute burns, Baran Singh was in physical pain and mental agony. The absence of any medical facility in the 90 km vicinity of Shyampur (Surguja) affected not just his livelihood and but his daily activities too. Adani Foundation's Mobile Health Care Unit (MHCU), striving to provide quality healthcare services to remote areas, provided him effective medical treatment, free-of-cost, and today he is living his life with a new hope.

An MHCU covers 14 villages near the mining site and 31 villages near the railway corridor. It has treated 47,747 patients. A clinic, run under business, is open to the villages and has treated more than 5,000 patients.

Dhamra (Odisha)

The Adani Foundation, Dhamra, has a two-pronged approach to provide healthcare services to communities around the port. A clinic treated 26,909 patients, and an MHCU reached out to 13 Gram Panchayat villages and provided 2,512 free treatments.

The Maa Dhamarai Fishermen Association and Management Society, Dhamra Fishing Harbour, highly appreciated the Foundation's efforts in supporting 35 schools and 260 registered boats & trawlers with first aid kits to deal with emergencies catering to fishermen in the vicinity.

Seven mega health camps were organised in January & February 2017, where renowned specialists from all branches treated referral cases as well as general public. In all, 4,795 patients benefited from these camps at their doorstep locations.

Water purifiers and seating mats were provided to 44 Anganwadis from the peripheral villages of Chandbali and Tihidi blocks. The Adani Foundation tries to bridge gaps and upgrade government facilities for optimum utilisation by the people.

Udupi (Karnataka)

The Mobile Health Care Unit (MHCU) at the Udupi site brings basic healthcare services to 30 surrounding villages by providing free consultations, required medicines and referral services. During the past year, 15,513 treatments were provided. Besides this, 100 poor and needy patients were supported through a medical assistance programme.

As a part of the Swachchh Bharat Abhiyan, UPCL provided 20 custom-made tiltable dustbins in prime locations of the Panchayats and villages of Yellur, Mudarangadi, Belapur, Palimar, Tenka, Bada and Padubidri. The respective Gram Panchayats have taken up the responsibility for collection and disposal of waste.

In addition to the Mobile Health Care Unit (MHCU) services, the Foundation is conducting mega medical camps in the periphery villages periodically. In these camps, expert doctors from renowned hospitals like KMC – Manipal, KMC Mangalore, A.J. Institute of Dental Sciences, Srinivasa Institute of Dental Sciences and Yenepoya Hospital were invited. These doctors are specialists in the fields of general practice, paediatrics, obstetrics, gynaecology, ophthalmology, orthopaedics, dentistry, etc. Besides required medicines, medical equipment such as glucometers with strips, digital blood pressure meters, spectacles, knee caps, etc. were also provided for better maintenance of health.

More than 2,000 families (with up to seven members) were provided medical insurance with a coverage of 50,000/- rupees through the Adani Aarogya Card.

Godda (Jharkhand)

Initially, one MHCU catered to 15 periphery villages and provided 11,630 free treatments.

Encouraged by its utilisation, one more MHCU was added in March 2017 which will serve 30 additional villages. It has already reached out to 1,487 patients.

Nine mega medical camps and six eye camps were organised in the villages of Buxara, Sondiha, Motia, Amlo, Pratappur, Darghatta, Lohbandha, Pakaria, Maldih, Sondiha, Rangania, Basantpur and Dumaria in Jharkhand. A total of 5,114 patients benefited from these camps. In all, 107 people were supported with spectacles, and 25 patients were supported for surgeries worth Rs. 4500/- each.

Besides these, various need-based entry point welfare activities were carried out benefiting more than 4,500 needy community residents.

Shimla (Himachal Pradesh)

Since its inception in 2008, the Adani Foundation has been serving 28 villages in Kotkhai, Theog and Chopal blocks of Shimla and Kullu. The Mobile Health Care Unit (MHCU) and









medical camps provided 7,126 treatments while the clinic at Sainj treated 404 patients. The work of the Foundation's healthcare team has been appreciated for its dedicated efforts in such a difficult terrain.

Vizhinjam (Kerala)

In order to support the Trivandrum Municipal Corporation's drive of solid waste management, the Adani Foundation has already constructed 21 Thumoor Mozhi Aerobins out of a total of 26 for the wards of Kottapuram, Vizhinjam and Harbour. These bins will handle the wet waste of 6,000 families and produce compost in a cycle of 30-40 days.

In an immediate response to heavy rains in May 2016, the Foundation supported the communities with food and sleeping mats. An assessment committee was formed and on the basis of their recommendations, repair work was taken up in various public and private households. Monetary compensation was also given out to deal with the difficult situation of insurmountable losses.

Under a community engagement and volunteering programme, three batches of youth(two batches of 90 men and one batch of 45 women) underwent three-day training where they first identified the core issue on which they, as a group, would like to work. This initiative has helped build ownership of the local youth as well as leadership qualities and problem-solving techniques among them.

Empowerment is the key to transforming lives

Empowering people through a sustainable livelihood gives them an opportunity to transform their lives. The image of a rapidly growing economy doesn't always accurately reflect the socio-economic situation of the people. Every year, young people with enormous potential enter the workforce but are unable to find decent employment. The lack of opportunities to develop adequate skills restricts many people from maintaining a decent standard of living. Hence, it has become imperative for the nation to invest effort in the skilling of its workforce.

At the Adani Foundation, we believe that helping people become self-reliant and earn sufficient incomes will counter poverty and unemployment. Our Sustainable Livelihood Initiatives include shelter support and alternative income generation methods, promoting women empowerment schemes and self-help groups, etc. We work with youth to develop their capacity and employability through skill development training programmes. This training helps them in practising alternative vocations during financially weak periods and maintaining a sustained income.





When you learn to fend for yourself, you don't just earn a new livelihood, you earn a new life. In India, concerns regarding socio-economic inequalities, due to various reasons, need to be addressed. The primary objective of the Adani Foundation's sustainable livelihood initiatives is holistic growth and development of the marginalised sections of the society by providing income augmenting opportunities in their traditional livelihood practices and skill development training for employability & entrepreneurship.

Sustainable Livelihood Development is one of the important areas covered by the activities of the Adani Foundation. The Foundation's initiatives aim at augmenting livelihood opportunities to improve the quality of life of the marginalised communities. A number of projects and programmes are designed and planned after understanding needs of the people. The Adani Foundation renders its services to various businesses of the Adani Group. The composition of communities and their needs vary according to the nature of business and its infrastructure in each location. The Foundation's welfare activities generally focus on marginalised and vulnerable groups including women, small farmers and cattle owners as well as unemployed youth.

Mundra (Gujarat)

The fisherfolk community and the Port business have always coexisted. When the Adani Group initiated port development and followed it with operations, the socioeconomic condition of the fisherfolk community was quite challenging. After the establishment of the Adani Foundation, as the CSR arm of the Adani Group in 1996, a strategy, based on giving priority to socio-economic development, was planned for the fisherfolk community. The Foundation intervened to provide quality livelihood to the fisherfolk, including women as priority group.

In Mundra, special programmes have been conducted to enhance the employability of youth from fisherfolk communities. Based on the need assessment results, several livelihood options have been introduced by the Adani Skill Development Centre, Mundra. In these centres, youth can join and get vocational training for a number of technical and non-technical skills. This vocational training is unique as it includes theory classes followed by practice on simulation equipment and lastly practical sessions. The programmes by the Centre have benefited 94 youth through various trainings.

Machhimar Ajivika Uparjan Yojana - Sustaining Livelihood

The 'Ajivika Uparjan Yojana' was implemented to promote and support alternative livelihoods among fisherfolk communities during non-fishing months. The Foundation introduced 'Mangrove Nursery Development and Plantation' in the area as an alternative income generating activity for the people of the region. Both men and women received





training on mangrove plantation, moss cleaning, etc. as per requirement. In addition to this, the Foundation also provided the community with employment equivalent to 3,315 man-days. Till date, employment worth of 25,000 man-days has been provided to the people of the community. The Foundation also supported 42 Pagadiya fishermen by providing them with labour employment of 5,068 man-days as painters.

New Initiatives

The main objective for promotion of alternative livelihood is to raise the economic standards of the fisherfolk while the second is to reduce the pressure on fishing as the only means of income. It was reported that a large number of fisherfolks are willing to diversify their occupation/methods of fishing. Therefore, polyculture and cage culture has been introduced to the fisherfolk community in order to encourage them in making the shift from fulltime to part-time fishing.

Polyculture – A New Beginning

The practice of culturing more than one species of aquatic organisms in the same unit of area (marine waters, ponds, streams and rivers) is called polyculture. It works on the principle of cultivating more species having diverse food habits within a particular unit of area.

The preparatory phase activities will involve capacity building and inputs from experts on required machinery, fish seeds and fish food. This would be followed by identification of sites feasible for polyculture and implementation

of the activities with participation of the fisherfolk communities who would take up all the responsibilities. Polyculture will definitely add value to the fishing occupation of the local fisherfolk community.

• Cage Culture – A Different Approach

The production method for raising aquatic species using enclosures or cages which are placed in water is known as cage culture. An expert institute would provide training to the selected fisherfolk in live lobster handling, seed transportation & quality testing, cage fabrication & deployment, lobster husbandry practices, harvest and marketing, etc. The first phase of exposure to this practice and cage



fabrication has been completed. This initiative was launched in the presence of Dr. Koya from CMFRI in March 2017.

• Fish Research Centre at Okha - Looking at the Future

Seaweeds are macrophytic algae, a primitive type of plant lacking true roots, stems and leaves. The word seaweed gives a wrong impression that it is a useless plant. Seaweeds are wonderful and highly useful plants of the sea. They grow in the shallow waters. The root systems and conducting tissues seen in terrestrial plants are absent in seaweeds. Most of them hold fast for attachment, while some drift loose in the sea. The Adani Foundation's team visited the Fish Research Centre at Okha to understand the same for future programmes.

Cage Culture, Mundra

Other Exposure Visits – New Ideas in Agriculture

In all, 30 farmers visited the Agri Asia Agriculture Technology Exhibition. There, they discussed about the results of Jivamutra and Kitchen Garden Feedback.

A group of farmers were taken on an exposure visit to see organic farming and the biogas bottling plant at Vaghodiya village near Vadodara, Gujarat. Organic Farming and Biogas are an comparatively new concept in agriculture in Mundra block. Organic products are in high demand today while biogas plants are eco-friendly and give excellent results.

Development in Agriculture and Animal Husbandry

The Adani Foundation has initiated an awareness programme for farmers in collaboration with the Krishi Vikas Kendra. The purpose of this project was to initiate village-wise integrated agricultural & allied development for sustaining the agricultural and socioeconomic situation of the farming community in the Mundra block. The outreach of this programme was approximately 70 farmers from five villages.

Women Empowerment Projects - Building Lives

Projects aimed at empowering women, encourage them to take control of their lives and help in building their confidence whether they are single, married or widowed. Such projects are some of the important initiatives taken by the Adani Foundation for development of sustainable livelihoods. The Foundation started training programmes with two major women's groups from the villages near Adani Power and Adani Ports. Both these groups, consisting of a total of 90 women, have successfully completed their training in preparing washing powder, phenyl, liquid for cleaning utensils and hand washing, etc. Now, they have started the Saheli Mahila Gruh Udyog at the Shantivan Colony in Mundra. Six





selected groups, with 15 members each, take care of different work like accounting, banking, marketing, administration, etc. as per their skill sets.

Other Activities of the Adani Foundation - Lending a Helping Hand

- The Foundation gave biogas support to nine farmers and facilitated a government subsidy. The farmers themselves also contributed to this activity.
- A pilot programme was undertaken by the Foundation for the families of 20 farmers wherein they were apprised of the benefits of kitchen gardens and were provided with kits consisting of a variety of seeds.

Date Marketing - Linking with Hope

In order to promote the selling of date fruits, the Adani Foundation has done various linkages for their marketing. More than 1,000 kg dates were sold in the Adani Residential Colonies of Ahmedabad and Surat.

Food for Cattle - Succouring Families

Every year the Adani Foundation provides fodder to every village, with the help of the local people, in the last three months of summer and during times of scarcity. This initiative gives stability to families who earn their livelihood through animal husbandry. In order to meet the demand for fodder, the Foundation purchases it from the regional farmers at fair rates. This year it has given fodder weighing 59,224 mann, worth Rs. 127 lakh approximately.

Coordination with Government for Widow and Senior Citizen Scheme

The Adani Foundation is playing the role of a facilitator in government schemes for widows, senior citizens and people with disabilities (PWD). During the past year, a total of 454 people including 63 widows, 40 senior citizens and 351 PWDs got benefits from the

approval of pension certificates. The financial benefit under the scheme for senior citizens is Rs. 400 per month while the benefit under the scheme for widows is of Rs. 900 per month.

Beti Vadhavo Abhiyan – for the Girl Child

Various meetings were organised, under the Beti Vadhavo Abhiyan, in 32 villages in the presence of the Sarpanch and other leaders. The Adani Foundation's team discussed topics like the importance of girl child, sex ratio, gender equality and laws regarding child abortion. This initiative was well accepted by the community and the Foundation has observed a visible change in their mindset. eti Vadhavo Abhiyan, Mundra

Uphaar – Livelihood Through Meal Services

The Adani Foundation has been striving to revive and nurture Self-Help Groups (SHGs) of women in villages near the Hazira site. These groups are voluntarily formed on areas of common interest so that the members can think, organise and operate for their development. These SHGs function on the principles of cooperatives and provide a forum for members to extend support to each other. Two women groups - one from Suvali (with members from five different Sakhi Mandals) and another from Rajgiri (with members of Shree Sai Sakhi Mandal) - experimented with various income generation activities where savings was one of the main objectives. They prepared and provided nutritious food to Anganwadis to help the Foundation in curbing malnutrition. Besides this, they also made articles that sell during festivities.

Encouraged by these initial experiences, they decided to venture into 'Upahar' – a meal service for truck drivers. Later, it was expanded into running a canteen at the Adani House. They underwent all the training and hand-holding for planning, budgeting, handling ups &downs and risk management just like an enterprise. This project has flourished, and now, it is reaching out to 100 truckers on a daily basis. This experiment has created a win-win situation where the truckers get home-cooked nutritious fresh food and the women earn money.

Support to Fisherfolk - Lighting the Path to Self-reliance

The fisherfolk communities are a highly important stakeholder group for the port. Their needs of fishing nets and solar lanterns were identified through a thorough need





assessment and participatory rural appraisal process. These items were provided to the fishermen to augment their livelihood. This timely support has spared them from getting caught in debt cycles.

Support to Frisbee Team – Promoting Sports in Rural areas

A frisbee team was formed during 2014-15 to promote the game among rural youth. The idea behind the formation of this team was to enhance children's cognitive & physical development with the help of sports. The team has chosen 'Chakmak' as their name and participates in various competitions, representing the Adani Foundation. The team participated in the Ahmedabad Ultimate Open and won the tournament this year. The Adani Foundation provided the team with special uniform, inclusive of shoes, as well as logistics support for participating in this event.

Dahej (Gujarat)

Support to the Fisherfolk Community – Bringing Light to their Lives

The Adani Foundation has identified fisherfolk communities as a vulnerable group. They have been supported with fishing equipment and getting the licenses in the past. After consultations with these groups, it was found that lanterns and mobile charging points were needed. The Foundation identified 198 licensed fishermen and provided them with solar lanterns. Along with giving safety, security and light during fishing at odd hours, the solar lanterns will also provide plug points for charging mobiles. This will help the fishermen stay connected with family and friends.

Community Engagement Programmes – for the Welfare of the People

The nearby villages fall under a highly concentrated industrial zone where heavy motored vehicles are present on most of the main roads. Hence, with the aim of educating them about road traffic safety while commuting, the Foundation's team in Dahej facilitated an awareness session for the youth of these villages on the occasion of National Traffic Safety Week. Traffic safety training was given to two-wheeler riders. Safety equipment such as helmets and reflective jackets were also provided as a safeguard while riding or



walking respectively. This initiative directly benefited 200 people from the nearby villages.

The Adani Foundation is actively involved with the youth groups of all the cluster villages. Every year, it organises the Adani Cricket Tournament which has limited over matches in a knock-out series. This year's tournament witnessed a high surge in participation. A total of 288 participants from all the cluster villages, forming 24 teams, registered themselves. The tournament also attracts volunteers from the villages as well as port employees. It has proved to be a highly fruitful community engagement activity which also nurtures sportsman spirit and leadership among the youth. Besides this, the Foundation has also assumed the responsibility of making the surrounding villages greener and performing environmental friendly activities with the participation of the local communities.

Tirora (Maharashtra)

Systematic Rice Intensification Technique - Bringing a Positive Change

Agriculture is indeed the noblest of all alchemy; for it turns earth, and even manure, into gold, conferring upon its cultivator an additional reward. In the Tirora region of Maharashtra and its surrounding villages, agriculture has always been the primary source of livelihood. It is predominantly known as the paddy belt of Maharashtra. However, the traditional methods of paddy cultivation and the lack of exposure & technical awareness among farmers have been taking a toll on the per hectare production of rice in the fields.

On a pilot basis three years ago, the Adani Foundation had introduced 81 farmers to the Systematic Rice Intensification (SRI) method. During the pilot phase, 1,050 farmers, from 35 villages of the region, effectively implemented the SRI technique on 1,050 acres of farmland. Besides this, in order to keep the farmers updated with the necessary awareness







& knowledge about SRI, the Adani Foundation also empowered them with training for adopting low water & labour-intensive organic method of reaping. The farmers garnered a profit of Rs. 5 crore with an investment of Rs. 20 lakh from the Foundation. Today, the Foundation has roped in 950 more farmers from 42 villages who have adopted the SRI technique covering a total of 2,684 acres of land.

Sewing Training – Developing Entrepreneurship Qualities

Two batches of 40 women underwent training for sewing at Mendipur and Tirora in collaboration with Jan Sahayog Shikshan Sansthan, Gondiya. Few of them will adopt sewing and garment making as an entrepreneurial venture, and the rest will use it at the household and known clientele level.

Vanmahotsav - Sowing the Seeds of the Future

The Adani Foundation celebrated Vanmahotsav on July 1, 2016, in the Tirora block and its peripheral villages and schools aligning with the Vanmahotsav by the Government of Maharashtra.

Cow-Based Livelihood Training Programme – Expanding Horizons

Amongst many programmes on the development of sustainable livelihood, the Foundation has a highly innovative cow-based livelihood programme in the Tirora block. This programme has been developed with the aim of safeguarding the economic security of the marginalised communities. The programme has been rolled out in a total of 18 villages with a primary focus on generating income for women.

Like most of the other programmes, this particular livelihood-based intervention has been designed keeping in mind the existing structure of the area. Agriculture and its related activities are one of the major occupations in the adjoining villages of Tirora. Due to this

most households have cattle and derive some portion of livelihood by rearing them. However, lack of exposure has confined the communities to a very limited usage of the byproducts. Milk and dung are mainly used for personal purposes. Very few households trade

in these by-products. Sensing a huge potential in this field, the Foundation's team in Tirora developed the cow-based livelihood model and implemented it in a phase-wise manner.

This year, a three-day residential training programme was conducted at Go Vigyan Anusandhan Kendra, Devalapar, and the following topics were covered in it:

- Promoting organic farming
- Side-effects of chemical fertilisers
- Generating material and medicines from cow dung
- Production of vermin compost and compost fertiliser
- Pesticide from cow urine
- Information about income generation from cow dung & urine

Fly Ash Utilisation Programme – Innovative Farming

Fly ash which is a by-product of the thermal power plant has multiple uses. A company had roped in the Council of Scientific & Industrial Research-Advanced Materials & Processes Research Institute, Bhopal, a government organisation, for exploring the use of fly ash in agriculture. Demonstration plots called 'Eco Plots' were prepared at a plant which yielded positive results i.e. 22% increase in yield for two years. Encouraged by this success, groups of 82 farmers were invited and engaged in training at the Eco plots. The methods and benefits of fly ash utilisation, including the right amount to be used, were explained to them. Currently, 12 farmers are trying out this method on a pilot basis on an average one-acre plot in their farms.

Mushroom Cultivation Training – Growing Treasure

Mushroom farming can bring substantial profits in just a few weeks. A Mushroom Cultivation Training Programme was organised on October 6 to 8, 2016, for women SHGs from Berdipar village with the following objectives:

- Capacity building of the women
- Income generation for the women

A total of 30 participants attended the training, and after completing it, they started cultivating









mushrooms. Today, they are selling mushrooms at Rs. 200 per kg.

Training Programme for Formation of Farmers Producers Company

A two-day training programme for the formation of the Farmers Producers Company was organised on October 20 & 21, 2016 for 20 farmers' group leaders, 9 village volunteers and the Adani Foundation's team in Tirora. The objectives of this programme were:

- To promote economically viable, democratic, and self-governing Farmer Producer Organisations (FPOs)
- To provide support for the promotion of such FPOs by qualified and experienced resource institutions

- To provide required assistance and resources – policy actions, inputs, technical knowledge, financial resources and infrastructure – to strengthen these FPOs

Workshops on Cashless Transaction – Going Digital

To ease the inconvenience faced by people during the first few months post demonetization, training workshops on cashless transactions were organised in collaboration with and under the guidance of the Sub Divisional Office, Tirora.

Workshop on Lac Bangle Making – a Colourful Livelihood

Lac is considered to be the oldest source of colour, and it has always been very popular. Lac bangles and jewellery are adorned and appreciated by women since generations. The Adani Foundation, in collaboration with the SARDA Organisation, conducted a ten-day workshop on lac bangle making for SHG women from the nearby villages of Adani Power Maharashtra Limited. In this skill training programme, women participants acquired practical knowledge on making attractive bangles and various jewellery items from lac. Apart from it, they also learned skills of packaging and marketing of these bangles and other jewellery items which will enable them to earn handsome income.



Kawai (Rajasthan)

Sewing and Garment Making Training for Women - Fostering Confidence and Self Reliance

The Adani Foundation organised a training session in sewing & garment making in which 60 women from four peripheral villages participated whole-heartedly. After completion of the first batch, the Foundation organised an exhibition of the articles produced by the trainees. Eight women out of this group have already taken up sewing as an entrepreneurial venture and earn an average of Rs. 2,500-3,000 per month. Other women are honing their skills by sewing for their families while some barter which is still prevalent in the villages.

> Cattle Breed Improvement Programme – an Initiative for a Positive Impact

Sewing and Garment Making Training for Women, Kawai

The Adani Foundation has initiated a cattle breed improvement programme at Kawai. The Foundation is developing Integrated Livestock Development Centres (ILDCs) in the

nearby villages. The two planned ILDCs will cover 28 villages in the vicinity benefiting 8,643 breedable cattle. During the past year, a survey of milch cattle, artificial insemination awareness meetings at six Gram Panchayats and 21 villages were carried out in the preparatory phase. Veterinarians and other experts also covered the use of proper fodder for the cattle.

Surguja (Chhattisgarh)

Annapurna Project - Forming the Farmers' Producers Company

The Annapurna Project is a CSR initiative to promote vegetable, maize and mushroom cultivation as an alternative livelihood in association with the Gram Panchayats of Salhi, Parsa, Basen, Ghatbarra, Shivnagar and Salka villages. This project is designed to be participatory in nature. In the cultivation of vegetables and maize, the contribution of farmers, through the Farmers' Club and Adani Enterprises Limited, is 40%, while that of the CSR wing of RVUNL is 60%. This is an important step towards the formation of the Farmers' Producers Company. So far, 22 Farmers' Clubs consist of 244 members. The Farmers' Clubs have opened accounts in the Regional Rural Bank, Dandgaon of Udaipur block, Surguja district, and the Regional Rural Bank, Shivnagar of Premnagar block, Surajpur district. This project was inaugurated on June 30, 2016.

The farmers sell potatoes after grading them into three types: sabji/chips, dam and bhujiya







aloo. They managed storage of more than 40 tonnes of potatoes at the Durga Cold Store, Ambikapur. In the two villages of Basen and Fatehpur, 100 families are involved in mushroom cultivation. So far, they have produced four quintals of mushrooms from 1,000 bags.

Vasundhara Project - Farming Alternative Livelihoods

Broad objective

Project Vasundhara's broad objective is to develop sustainable livelihood opportunities for participating tribal communities through remunerative self-employment and thus prevent migration.

Specific objectives

- Effective utilisation of available land, water and manpower resources of selected tribal families through participatory approach
- Implementation of environmentally friendly income generating activities
- Development through people's organisations
- Participation by women in the development process and their empowerment.
- Improvement in scenarios of health, sanitation and access to drinking water
- Demonstration of merits of 'Vasundhara Farm' model for replication of the same by various developmental agencies
- Adoption of technology by other farmers in the project area

Formation of Women Producers' Co-operative – Uniting to Forge a Future

On January 7, 2017 members of 50 SHGs of Salhi, Hariharpur, Parsa, Basen, Ghatbarra and Fatehpur villages assembled at the Adani Rural Resource Centre to form a women producers' co-operative. This co-operative would provide livelihood opportunities through village-based enterprises such as making spices, papads, white phenyl, agarbattis, handicrafts, bari as well as mushroom cultivation & processing and apparel production,



etc. The members finalised on 'Mahila Udyami Bahuuddeshiya Sahkari Samiti' (MUBSS) as the name of the co-operative.

The achievements of the co-operative include stitching of 922 school uniforms for the Adani Vidya Mandir, Surguja and 832 school uniforms for the Adani Vidya Mandir, Bhadreshwar (in Gujarat). The group was also successful in generating income through making papads and chips.

Handpump Repairing and Maintenance Training – Building New Skills

Women Producer Co-operative Papad Making, Surguja

Seven-day training programme in hand pump repairing was organised at the Adani Rural Resource Center, Basen. Nineteen youths from Parsa, Salhi, Basen, Ghatbarra and Janardanpur learnt basic skills of handpump repairing. During the seven-day programme, a total of 18 defunct hand pumps were also repaired in the villages of Kente, Ghatbbara, Fatehpur and Parsa.

Training in Soft Toy Making – Augmenting Incomes

A fifteen-day training in making cushions, soft toys, bags and other fancy decorative items was given to 20 women of Salhi, Fatehpur and Hariharpur villages at the Adani Rural Resource Centre (AARC), Basen. The key outcomes of this training were:

- Exhibition of items during Safety Fortnight at Parsa coal mines
- Exhibition of items in Anand Mela organised by Spandan Adani Ladies Club, Gumga
- Rs. 5000/- income generated

LMV Driving Training for Women – Empowerment in a New Direction

To develop driving skills among women, a one-month training session in driving Light Motor Vehicles (LMVs) was given to 26 women from villages including those of Parsa, Kete, Salhi and Ghatbarra. This training was provided by Tej Singh Motor Driving School, at the Parsa Sports Ground. Out of the 26 trainees, 5 opted for LMV driving as a profession.

Swachhata Drive - Towards a Clean India

This drive was started in the peripheral villages of Parsa Kente Colliery with the involvement of the respective Gram Panchayats. In LMV Driving Training for Women, Surguja

Parsa village, a household survey of toilet usage was conducted and the outcomes were shared with PRI members. Awareness programmes, rallies, Swachhata classes, Jao Puchho Abhiyan, wall writings depicted with pictures and video shows were organised to sensitise individuals for maintaining hygiene and sanitation. PRI members, SHG members, students, shopkeepers and other stakeholders were also involved in the activities.

Dhamra (Odisha)

Animal Health and Vaccination Camp - Caring for Livestock

The Adani Foundation's team with the help of community members and village volunteers organised an Animal Health and Vaccination Camp on November 27, 2016, in the Dosinga village of Dosinga Gram Panchayat and on November 29, 2016, in Kuntala, Bhadrak. Expert veterinary doctors and surgeons provided their services at the camp.

Tailoring Unit - an Initiative for Growth and Development

The Adani Foundation runs a Tailoring Unit for training in sewing and garment making. As the socio-economic development of women in this area are of major concern, this tailoring unit was started in July 2016 with an objective of training young girls and women and empowering them for earning a livelihood. A batch of 10 trainees started on July 11, 2016 and continued for six months, four days a week. The trainees learnt cutting, stitching and alteration of clothes and dresses as well as dressmaking.

Udupi (Karnataka)

Plantation and Social Forestry-Helping the Environment Flourish

Under one of its forestry programmes, the Adani Foundation reached out to 70 government & government-aided schools located in the Udupi district. It distributed two fruit-bearing tree saplings to every student, teacher and SDMC member of these schools.

In all, 25,000 saplings were planted by 4,500 children and 700 teachers & SDMC members on the premises of all their respective schools. Saplings of species like sapodilla (chickoo), rambutan, mango, jackfruit, coconut and areca nut were distributed.

UPCL, in association with the Adani Foundation, conducted the Vanamahotsav programme in co-ordination with the Gram Panchayats and distributed lakhs of quality saplings to the villagers of Yellur, Mudarangadi, Belapu, Bada, Tenka and Palimar Gram Panchayats. UPCL has supported the government's Koti Vruksha Abhiyan. The Foundation also provided vegetable

seedlings to villagers in 20 Gram Panchayats during the Vanamahotsav

celebration for which nearly 25,000 saplings worth Rs. 20 lakh were purchased. The plantation of fruit-bearing saplings will not only promote greenery in the villages in the vicinity of the plant but also help families in sustaining their livelihoods.

Support to Rural Sports and Games - Conserving Tradition

The districts of Dakshina Kannada & Udupi are known for various traditional sports and cultural activities. In order to promote these activities, the Adani Foundation is extending necessary support to various associations, educational institutions and sports clubs engaged in them. The support provided to the Kambala and Kesaragadde events and other rural sports are a few examples of the Foundation's whole-hearted actions. In terms of cultural activities, the Foundation is supporting Alva's Virasat, Pratibha Puraskaara, etc.

Community Engagement Programme – Encouraging Cultural Events

The Adani Foundation supports many organisations, schools and colleges in arranging cultural events. In the past year, 12 such organisations have been provided with the necessary support for holding cultural events.

Socio-economic Survey – Planning for the Future

The Foundation's approach is to plan and implement projects and activities which are need-based and participatory in nature. A socio-economic survey was conducted in

In 2016, she enrolled in the Saksham Sewing Center, started by Adani Foundation, to master the art of tailoring. Post this, she started her own tailoring venture. Using the money she earned, she went on to pursue Bachelor of Arts and also returned the money she had borrowed from her father to purchase the domestic sewing machine. Earning Rs. 4000 per month, she is grateful to Adani Foundation for giving her the gift of freedom, value and empowerment.

thirteen villages covering 3,100 households approximately. The detailed data of the households is at the disposal of the Foundation to analyse and plan for initiatives that will directly benefit the local community.

Cattle Health Camps – Caring for Livestock

Six cattle health camps were organised in collaboration with the Animal Husbandry Department in five villages of Godda and Poraiyahat blocks. A total of 866 cattle including calves, cows, and buffalos were treated in these camps.

Formation of SHGs – Empowering Women

Five Self-Help Groups (SHGs) of women have been formed in four villages Sondiha, Motiya, Ranitikar, and Ranganiya. The by-laws of these SHGs have also been formed. Apart from this, 18 SHG members of Basantpur village are being provided with regular material and training support. A total of 225 women members have been motivated for development initiatives.

Linkage to Government Welfare Schemes

- With the help of the Foundation, 1,800 unskilled and semiskilled labourers from all the villages got enrolled with the labour department under various labour welfare schemes.
 As a result of this, the labourers are now entitled to get benefits under 18 schemes of the government.
- So far 235 applications have been received to avail benefit under various government scheme linked programmes. The forms have been submitted to the government department to enrol the same under social security schemes of the government.

Relief Work - Rebuilding Lives

The Foundation carried out relief work in five villages of the Poraiyahat block, adversely hit by a hailstorm. Support was given to 200 households. The local community members and village leaders were also involved in the process. Under this relief drive, food items, tarpaulins and medical services were provided to people

as well as their livestock.

Support Towards Cultural Programmes Celebrating the Sohrai Festival

- Traditional clothing was provided to 250 households from the Santhal tribes as a gesture of goodwill on the occasion of the Sohrai festival in the tribal villages falling under the Adani Foundation's working area including Gangta, Nayabad and Petbi.
- The local community was supported in various festivals and on several social occasions like Durga Puja, Chhath Puja, Saraswati Puja, Chaiti Durga, Holi and many other local festivals.

- Several community engagement exercises have been done in the villages in the form of meetings, consultations, planning for the programmes, sports tournaments, etc.

Harbour Canteen-Vizhinjam

In September 2016, the Adani Foundation provided basic management training to women in the harbour ward of Vizhinjam in Trivandrum Corporation. The women were trained in Business Management, Cash Management, Debt Management, Leadership and Sales strategies. Smt. Shini and Smt. Sumina along with three other women from the group started running their own canteen from 1st December, 2016. With a thriving business, they are an inspiration; not just selfemployed but creating employment opportunities for others too.





Livelihood Management Training – Inspiring New Beginnings

Around 576 women belonging to BPL families from the wards of Kottappuram, Venganoor, Vizhinjam and Harbour were trained in the following management modules:

- Self-management
- Cash management
- Debt management
- Leadership

The trained members were then grouped on the basis of their skill sets and aptitudes as well as 13 livelihood activities including community lab work, catering, food processing, cleaning, event management, production of paper and eco-friendly bags, tailoring, etc. Following this 101 members were given product training.

Agri-Karmasena is a name chosen by one of the groups. In their area, the people have land to use for agriculture. They will be doing organic farming and marketing organic produce. This group will also encourage other land holding women to start organic farming.

Another outcome of the Livelihood Management Training is that one of the trained groups took the initiative to become entrepreneurs. It opened a canteen at the Employee Canteen of the Harbour Engineering Department on January 9, 2017. This group consists of five women from the Harbour ward. At present, it prepares and sells breakfast, lunch and tea snacks. It has nearly 100 walk-in customers on a day-to-day basis. It has also started a catering service unit along with canteen.

Inspired by the Foundation's Livelihood Management Training, the members of Sree Bhadra Carry Bag Unit streamlined their business activities. They started going to different shops, took orders, made carry bags and supplied them in time. The members of this unit are Smt.Sini (33), Smt. Bindu (35), Smt. Sheeja (33). The members directly collect orders from the shop and make carry bags at one of the member's house.

Rural Infrastructure Development

Rural infrastructure is the first step towards **transforming lives**

A key element in the nation's growth story, quality rural infrastructure bears a direct positive influence on the development of the rural population. To achieve redistributive growth and alleviate poverty in India, the gaps in rural infrastructure need to be addressed. It is also a vital factor determining the success of sustainable poverty reduction programmes.

At the Adani Foundation, we believe that the rural sector has high potential in contributing to the economy. Hence, we have directed our efforts towards providing basic infrastructure facilities in the rural areas to overcome developmental challenges. Our rural infrastructure projects include providing infrastructure for education and upgradation of community facility at the village. For issues directly impacting health, we have implemented programmes for water conservation, construction of check dams, and provision of clean drinking water through water tankers as well as drilling of borewells.

We are committed to rural development through long-term investments for building sustainable rural infrastructure and transforming lives.

Rural Infrastructure Development

The Adani Foundation attempts to work for the betterment of the rural areas by developing its infrastructure and fulfils its goal of caring for the community and its people.

The Adani Foundation is committed to bridge the gap in infrastructure of villages and areas of its influence for betterment in living condition and all round development. Needbased infrastructure projects are being carried out for water conservation & supply, and to upgrade infrastructure in the fields of education, health and sanitation along with holistic development of the areas.

Mundra (Gujarat)

Water Conservation and Drinking Water Related Projects

In Mundra, groundwater is the main source of water. Unfortunately, it has a high level of TDS which causes bone and kidney diseases. Considering the need for clean drinking water, the Adani Foundation has taken initiatives for water conservation which include pond deepening work and construction of check dams. This year pond deepening was carried out in the villages of Dhrub and Mota Bhadiya while an earthen bund was constructed across the river between the villages of Baroi and Bhujpur.

Potable drinking water is the primary requirement of every village. Thus, the Adani Foundation has installed an RO Plant in Chhach Vistar at Zarpara. It has also constructed an underground tank with a capacity of 1 lakh litre at Rampar village of Anjar taluka.







Education Related Projects – Building a Strong Foundation

To improve the quality of education and the learning environment in schools, the Adani Foundation supports infrastructure development on a need basis. The Foundation has constructed a science laboratory at the Government Science School, Mundra and has also repaired toilets and kitchen at the Adani Vidya Mandir, Bhadreshwar.

Health and Sanitation Related Projects - Ensuring **Better Hygiene**

The Adani Foundation has constructed 15 individual toilets at Juna Madhapar village in Bhuj, in consultation with the District Collector to provide better basic facilities and hygiene options. Also, it has constructed 230 individual toilets for fishermen at Vasahat.

Fisherfolk Development Activities – Benefitting the Community

One of the primary objectives of the Adani Foundation is the development of the marginalised fisherfolk community of this region. In order to raise their standard of living, the Foundation is constructing roads for connectivity, facilities for clean drinking water, spaces for drying fish and providing solar lights for illuminating settlements.

Fisherfolk communities reside near the coast during most of the year except for the monsoon season. The Foundation has initiated a programme which will support the community in developing proper temporary shelters near the coast. During the past year, 140 shelters were refurbished at Juna Bandar and a road measuring 2,300 m

was developed. Under other programmes for the upgradation of infrastructure in villages, the Foundation constructed an approach road of 11 km in Vadivistaar of Zarpara.

Hazira (Gujarat)

Community Halls- Fulfilling Social Requirements

Halls for social gatherings of the community were required in the villages of Bhatlai, Vasva and Dummas. In response to these need-based demands, the Adani Foundation constructed community halls and toilet facilities in these areas in the past year. This work will benefit a total population of 5,566.

Construction of Shelters – Reinforcing Homes

Considering the demands and needs of socially-economically marginalised communities, the Foundation is facilitating reconstruction shelters with toilet. In the past year, it has constructed 29 houses in the villages of Vansava and Rajgiri. A total of 120 people from 29 families will benefit from these shelters.

Other Activities – Improving Community Infrastructure

The Adani Foundation undertook several other activities like the renovation of the school at Suvali, construction of a paved surface at the Hazira GP office and the crematorium in Vansava to improve the infrastructure of the community. It also installed an RO plant at Barbodhan and undertook pond pitching work and beautification in Mora village. Community Hall, Bhatlai

Dahej (Gujarat)

Construction and Repairing of Houses- for a Decent Standard of Living

Many houses belonging to the marginalised groups within the community are in a dilapidated or severely damaged condition. They are unbale to withstand harsh weather conditions and in dire need of repair and reconstruction. Taking this situation into account, the Adani Foundation has taken the initiative of construction work. In the past year, 13 houses are reconstructed at Lakhigam and Luvara under this programme. In addition to this, 68 houses were repaired at Jageshwar. This initiative has not only







provided 81 families with shelter and protection against the weather, but it has also improved their living conditions.

Upgradation of Infrastructure in the Villages- Amenities for All

The Adani Foundation has enhanced the infrastructure of primary schools in Lakhigam and Dahej by constructing dust-free areas with paver blocks and raising height of walls for safety of the children. This has benefited 1,394 children from these schools.

The Foundation has also built a bus stand for the commuting passengers, community toilet block facilities and an underground water tank equipped with a washing area at different places in Lakhigam. These initiatives have benefited 9,900 inhabitants of this village.

Due to lack of proper lighting facilities, the village of Luvara used to immerse in complete darkness at night. Hence, the initiative of providing solar lighting facilities, which utilise a renewable source of energy, was undertaken. Now, the village is lit up by solar lights at night, benefitting 3,376 people.

Water Conservation - Pond Deepening, Stream Widening and Farm Pond Work

The Gondiya district falls in the arid zone of Vidarbha region in Maharashtra. It receives an average annual precipitation of 1,160 mm from south-west monsoons. Although the annual rainfall received is good, the erratic nature of monsoons leads to long dry spells and an acute shortage of water which underscores the need to recharge water bodies and efficiently manage available resources.

The Adani Foundation has taken the important initiative of implementing a water conservation programme. Under this programme, deepening and desalting of existing village ponds is undertaken to increase their storage capacity and enhance recharging of the subsoil water table. The Government of Maharashtra has also initiated a water conservation scheme under the banner 'Jal Yukt Shivar Abhiyan. The Foundation is the biggest contributor to this programme and has been well appreciated by the District Collector of Gondiya for its work in this district.

During 2016-17, the Adani Foundation has deepened 39 ponds, creating an extra storage capacity of 1,51,330 m³. In all, 21 streams have been deepened leading to an extra storage capacity of 83,924 m³. In addition to this, 21 farm ponds were developed in seven villages making for an extra storage capacity of 9,660 m³. This work has benefited 3,012 acres of land, 924 wells, 387 borewells and 1,224 farmers whose lands are close to these water







bodies. A total of 24 villages have been covered under this water conservation programme.

Drinking Water Facilities in the Villages – Improving Access to Water

The Adani Foundation has installed three RO plants at Kachevani, Khairbodi and Gumadhwada respectively. These plants will provide clean potable drinking water to 6,642 people from these villages. Also, 12 borewells were drilled and hand pumps were installed at different locations in the villages, due to which a population of 4,475 living in close proximity will benefit from this provision of clean source of water.

Other Infrastructural Works – Enhancing Social and Educational Environment

Considering the lack, and therefore the need of seating podiums and benches in the villages, the Adani Foundation has provided seating benches in the public places of 32 villages in the last two years. In 2016-17, the Foundation installed 200 benches in 43 villages, fulfilling their requirements. It has also constructed additional classrooms in government schools at Chikhli, Berdipar, Chirekhani, Churdi and the Zilla Panchayat Kanya High School, Tirora. These measures were taken to upgrade existing infrastructure and ensure a good learning environment in these schools.

Developing Model Talab At Antana Under Government of Rajasthan's MJSA Programme

The Jal Swavlamban Abhiyan has been launched in the state of Rajasthan. As a part of its contribution towards this programme, the Adani Foundation has adopted the Antana talab

(lake). It has carried out excavation, stone pitching, ghat construction and beautification work at this talab. These efforts in the direction of water conservation were highly appreciated by the Hon'ble Chief Minister of Rajasthan in her public address during the visit to this site. The Foundation has contributed Rs. 50 lakh to this initiative which will benefit around 3,500 people living in this area.

Construction of OPD Block at General Hospital in Baran

There was an urgent need for proper infrastructure at the government hospital in Baran district which has a population of around 12 lakh. The Adani Foundation contributed Rs. 11 crore for construction of OPD block at this hospital. The Hon. Chief Minister of Rajasthan laid the foundation stone for this OPD block and the Nursing college. This project has been completed successfully and will benefit the entire population of Baran.

Development of Grazing Land at Kunjer Under Government of Rajasthan's Scheme

The Adani Foundation has planted approximately 7,500 medicinal and forest trees in 14 hectares of land. Besides constructing a check dam for water storage and conservation, the Foundation has also established borewells for watering the trees. In addition to this, a trench has also been constructed around the area to protect the grazing land from other wild animals. More than 150 people are getting daily wages from NREGA by working on this project. Model Talab, Antana

The OPD block at the General Hospital, constructed by the Adani Foundation has become a lifeline for 12 lakh people residing in the Baran District of Rajasthan. The Honourable Chief Minister laid the foundation for the hospital.





Other Infrastructural Works - Bettering Facilities

As part of its infrastructure development activities, the Adani Foundation constructed a water tank at Nimoda village for regular supply of potable water benefiting about 13,700 people. The Foundation also developed a cowshed in Kawai for 500 cattle and constructed a minor bridge at Aton, which has upgraded communication within the village and benefited a population of about 6,750. For the Chattarpura cluster, the Foundation has set up a bore with a submersible pump to improve water supply in the area.

Rural Sports – Encouraging Local Talent

To promote rural sports, the Foundation has provided support to sports activities in the area such as the Kawai Cricket Club Tournament wherein 40 teams of the Baran district participated. Support was also provided to the State-level Football Tournament at Atru.

Surguja (Chhattisgarh)

Education Related Infrastructure Work: Construction of State-of-the-art Building for AVM

The Adani Foundation started the Adani Vidya Mandir, Surguja, in 2013 to provide free of cost quality education to the children of the community. Presently, the school is functioning in government premises with limited infrastructure. In 2015-16, the Foundation, with the support of Adani Enterprises Limited (AEL), decided to construct an independent school building at Salhi.





Rural Infrastructure Development

In 2016-17, a school building was constructed with a built-up area of 3,783 m² on a plot of land measuring 15,620 m². This project undertaken to facilitate a high standard of education cost Rs. 11.5 crore. This landmark building is near completion, and the school is expected to start functioning from the new building in the academic year 2017-18.

A temple of education, Adani Vidya Mandir, Surguja established in 2013 continues to keep the lamp of education burning. It stands as a fine educational institution, providing high quality education, and all other ancillary facilities to 570 students, coming from underprivileged backgrounds in classes LKG to Grade VII.

Water Supply and Conservation - Supporting the Jeevan Amrit Project

The Adani Foundation whole-heartedly supports the Jeevan Amrit Project which is being run by the Parsa Gram Panchayat for supplying water to each and every household. As a part of this support, a water ATM has been installed at the Community Health Centre in Udaipur for the benefit of the people. Pond deepening work has also been undertaken at Deurpara, Salhi, to increase the capacity of the local pond.



The Adani Foundation, with the support of Adani Enterprises Limited, has planned to develop a vocational training centre at Salhi. The centre, floor area of 14,000 square feet, is nearly completed. It is expected to provide training to around 1,600 candidates. Additionally, it also has a residential hostel, with a capacity of 160, to provide accommodation facilities to students coming from distant areas. At the centre, training in manufacturing & service sectors with short term courses will be provided. This training will increase the

employability of youth in the community and improve their living standard.

Other Infrastructure Projects – for Better Connections

For benefit of the entire community, the Adani Foundation has taken measures like providing 45 solar lights to the villages of Basen & Salhi and installing solar pumps at six



villages to facilitate irrigation. The Foundation has also developed a 3.25 km link road joining Baigapara and Salhi to sports ground for better communication. The Foundation has constructed 70 household toilets in Hariharpura village, developed market platforms at Salhi and a stage at Ramgarh.

Dhamra (Odisha)

Construction of New Building for Adani-DAV Public School

The Adani Foundation, presently associated with DPCL and DAV College Trust, is running a school with limited infrastructure. In 2015-16, it decided to construct a new building for the Adani-DAV Public School. Land measuring 21,655 m² was procured on lease in Kuamara village for this project. In 2016-17, the construction of a school building with a builtup area measuring 3,501 m² was started. The estimated cost of this project is Rs. 17.28 crore. This project is at an advanced stage of completion.

Rural Infrastructure Development

Other Infrastructure Works – Enhancing Resources and Facilities

Improvement of rural roads, drinking water facilities, electrification in rural areas and health & education related infrastructure has always been a priority for CSR activities of the Dhamra Port. With the suggestions of the Rehabilitation and Periphery Development Advisory Committee (RPDAC), several infrastructure development projects were taken up by the port during the past year.

The Foundation helped sink 15 tube wells in the inhabited areas of Dosinga, Koithakhola, Jagula, Karanpalli and Gurudaspur facing water scarcity. Also, 25 toilet blocks were constructed in different government schools. For better communication between remote villages, 7 village roads were improved by metal/moorum filling and levelling. Earthen roads, in low-lying areas, are washed away by rains during monsoon. Hence, efforts are being made to construct and develop concrete sections in a phased manner. Under CSR activities, construction work worth Rs. 100 lakh was executed.

Udupi (Karnataka)

Safe Drinking Water and Sanitation Project – A Step Towards the Health of the Community

In the past year, UPCL, in collaboration with the Adani Foundation, has constructed and installed safe drinking water units in five villages namely Yellur, Mudarangadi, Tenka, Bada and Belapu. Each unit has a water-purifying capacity of 1,000 L/h and a storage capacity of 5,000 L. These units, utilising RO technology, have benefited nearly 3,500 villagers.

UPCL, in association with the Adani Foundation, has constructed toilets for girls in three government schools in Udupi city, Yellur village and Mudarangadi. These measures were taken under the 'Green Nurturing Programme' to safeguard the interests of girl students.

Godda (Jharkhand)

Provision of Drinking Water – Initiatives of the Utmost Importance

In order to resolve the water crisis, 30 existing hand pumps were repaired in the villages of this area. This has benefited a population of 3,000 people. Under the Nirmal Dhara initiative, submersible pumps in borewells along with overhead storage facility have been provided to 13 schools. The supply of clean water has benefited 3,000 students and staff. Also, a total of 14 recharge pits has been dug near the hand pumps and wells to check flowing water so that it goes into the pit itself. This was a major initiative under Swachhta Abhiyan.

Other Infrastructure Projects – Equipping Society with Better Facilities

The Adani Foundation has repaired and renovated a community hall in Ranganiya village. This hall is being used as a training centre for tailoring as well as computer learning. The Foundation repaired a road connecting the villages of Ranitikar and Maruabathan and has planned for street lights in important 'Chowks' of 11 villages and has already mounted a total of 260 street lights in the villages of Sondiha, Dumaria, Nayabad and Gangta. Considering the demands of the villages, a 'Chabutra' has been constructed in Basantpur village while the construction of five others is in progress. Renovation of temples at Basantpur, Buxara and Motiya has also been undertaken by the Foundation.

Vizhinjam (Kerala)

The Adani Foundation and Adani Vizhinjam Port Pvt. Ltd. (AVPPL) carry out projects in education, health & sanitation, water supply and skill development areas as a part of CSR activities.

Education Related Projects- Reinforcing the School Building

The school building of lower primary school in Harbour area was not safe, and the authorities had requested the Adani Foundation and AVPPL to reconstruct the building. A detailed plan for the school building was prepared and a work order amounting Rs. 83 lakh has been awarded. The construction work will commence as soon as the site is made available by the authorities. This work will benefit approximately 400 students of the primary school.

Health and Sanitation Projects- Putting Public Health First

Considering needs of the people of Vizhinjam, the authorities have decided to develop a full-fledged Community Health Centre with new infrastructure costing Rs. 7.5 crore. AVPPL has agreed to support the project by donating Rs. 1.5 crore for development of second floor. Also, the Adani Foundation has constructed toilets for public use in the wards of Harbour, Kottapuram and Vizhinjam.









Understanding how the needs of different people vary according to their circumstances, the Adani Foundation undertakes certain special projects which are of national priority and need innovative approach and special attention for large scale implementation. These special projects address different circumstance-based problems occurring in specific communities on a large scale.

SuPoshan – Combating Malnutrition

Malnutrition including Anaemia is a curse which keeps weakening the future generations of our country. The SuPoshan project was envisaged after studying and analysing the results of two programmes, one for reducing malnutrition and the other for anaemia, at Mundra and Tirora. The issues of malnutrition including anaemia are very complex. SuPoshan is a programme with a community-based management approach. It aims to effectively intervene and deal with malnutrition at multiple stages in life as given in the below diagram.

Veena Devagan – Sangini, Parsa, Surguja, Chhattisgarh

Veena Devagan, a Sangini constantly works with the families of children suffering from acute malnutrition. Illiteracy and ignorance in parents result in developing life threatening diseases. Today, the health of many of the severely acute malnourished (SAM) children, who were referred by her to the Child Malnourishment Treatment Centre in the village and received treatment, has improved. Their families, educated on the importance of proper nutrition by the Adani Foundation, are now much more active, careful and positive of their children's health.

Veena Devagan - Sangini, Parsa

> Project SuPoshan targets children within 0-5 years of age, adolescent girls, pregnant women, lactating mothers and women in the reproductive age, in general. 'Sangini' is a village health volunteer who plays a pivotal role in spreading awareness, referral and promoting behaviour change among the target groups to achieve the project objectives.

> After imparting training during May 2016, SuPoshan was implemented at 10 business sites covering 232 villages and 5 municipal wards. The project has selected 194 Sanginis and built their capacity for conducting household surveys. They are trained to take anthropometric measurements and identify Severely Acute Malnutrition (SAM) & Moderate Acute Malnutrition (MAM) using 'Measurements of Mid Upper Arm Circumference' (MUAC) tapes. They are also taught to conduct focused group discussions








and family counselling for behaviour change. Some of their notable achievements are given below.

- Visits were paid to 1.12 lakh families, and the objectives of the SuPoshan project were explained to them. Out of these, 9,000 were not part of panchayat records. So, conscious efforts were made to make this project all-inclusive and not leave out unrecorded families.
- For generating awareness and peer support, 671
 women's groups and 533 girls' groups were formed.
- More than 5,061 group discussions and 5,049 family counselling sessions were conducted covering a total of 51,800 women and adolescent girls.
- Anthropometric measurements of 30,000 children in the age group of 0-5 years were collected and screened. A total of 583 SAM children and 1,650 MAM children were identified.
- So far, 148 children have been referred to the Child Malnutrition Treatment Centre which is a government facility. Out of these, 120 children have moved successfully to a healthy status.
- Also, 412 SAM children are receiving home-based treatment through Ready to Use Therapeutic Food (RUTF) under the community-based management approach towards malnutrition.

For haemoglobin screening of adolescent girls and women, the non-invasive technique with ToucHb apparatus has been used since October 2016. So far, 8,933 women and 8,948









adolescent girls have been screened. The results (out of the total girls and women screened) were as follows:

Sanginis facilitate utilisation of the National Iron Plus Initiative, aided by focused group discussions on Anaemia, explaining simple definitions, symptoms, consequences and the importance of iron rich food & foods supporting iron absorption.

Case Study

Ishani Starts Walking

- Name Ishani Sanjot
- Age 13 months
- From Gundala village of Mundra taluka
- Presenting Problem Suffered from poor health and was unable to stand on her feet
- Diagnosis Identified as SAM child with a weight of 6.3 kg
- Reason She was not breastfed properly due to her mother's subsequent pregnancy.
- Treatment A SuPoshan Sangini started counselling Ishani's mother on complimentary feeding and taking appropriate care. After counselling, Ishani's mother was ready to take her to CMTC, Mundra, where she underwent 14 days of treatment.
- Outcome Her health improved with treatment, nutritious food, food preparation training given to her mother, and her weight increased to 7.7 kg. Proper care turned Ishani into a healthy child with a beaming smile who can not only stand but also walk without support.



Vansh Mehra – Kawai, Rajasthan

Vansh Mehra, an 11 month old child from the Mayatha village in Kawai, Rajasthan was identified as a severely acute malnourished (SAM) child and weighed only 5.5 kgs. Sangini Ruchika Mehra of the village counselled his parents and convinced them to send him to CMTC (Child Malnourishment Treatment Centre), Baran for treatment. Treated at the centre for 14 days and now weighing 8 kgs, his glowing face and full cheeks make him a sight to behold. His family expresses deep gratitude towards the team of the Adani Foundation, Kawai.





Swachhagraha – The Journey So Far

'Swachhagraha' is inspired by one of the largest mass movements - 'Satyagraha', that changed the fate of the country. The movement won over people's hearts through tremendous patience and perseverance, instilling in the Indian mind, dignity and self-respect.

Dealing with Health and Sanitation issue of adolescent girls

Indrabai Girls High School in Bhuj is one of the oldest schools committed to education of girls in the Kutch region in Gujarat. Lack of awareness regarding the usage and proper disposal of sanitary napkins leads to of improper disposal and its ill effects. A place where talking about menstrual hygiene is still a taboo, during a meeting with Prerak, Swachhagraha Dal Members came up with the solution to demonstrate to the girls of class 6 to 12, that how one should wrap sanitary napkins in an old newspaper, put in a plastic bag and discard in dustbins kept for dry waste. They were taught to put a red mark on used newspaper so that cleaning staff would also identify the waste inside the paper.

The project tries to address call for action of "Swachh Bharat Abhiyan" announced by the Honorable Prime Minister of India, Shri Narendra Modi; in a unique way. He emphasized on the importance of citizen's responsibility in sanitation. He says, it is not only the government's duty, but every citizen's duty to keep our villages and cities clean.

In continuation with this line of thought Swachhagraha is about promoting civic consciousness amongst citizens through young leaders. The heart of the project lies in 'creating a culture of cleanliness' in the upcoming generations of India. It aims to bring about lasting change through inculcating the 'Think, Explore, Discover, Act and Share' process during the formative years of life.

Swachhagraha Drive Tirora

Highlights

The Journey of Swachhagraha began with a pilot study in more than 12 schools of Ahmedabad by introducing the concept. It was well received by the students, teachers & school management. Encouraged by this response, the Foundation collaborated with the

Centre for Environment Education (CEE) for its School Intervention Programme. CEE was established in August 1984 as a centre of excellence supported by the Ministry of Environment and Forests, Government of India.

School Intervention Programme

A part of the Swachhagraha project, the School Intervention Programme was initially launched in six cities across Gujarat, namely Ahmedabad, Surat, Vadodara, Rajkot, Bhuj and Anand. It was also implemented in Mundra, Jasdan and Vidyanagar. Under this programme, efforts are directed towards creating and nurturing a culture of



cleanliness among school children, gradually extending to their families and neighbourhoods.

Various communication materials and tools such as Swachhagraha posters, brochures, websites, Facebook page, children's activity books and Swachhagraha Prerak - Teacher's guidebook, etc. were developed for a more meaningful implementation of the programme.

During the past year, more than 650 schools were active as Swachhagraha Schools having over 13,500 active Swachhagrahis (a person who practices Swachhagraha) and 1,350 Preraks in Gujarat. The communication regarding awareness and behaviour changes has reached to almost 3,25,000 students while the community outreach is more than 1,50,000. Besides Gujarat, the project is being implemented through online support in more than 70

Reducing the Waste in school canteen

Working on waste segregation, Swachhagrahi from Cosmos Castle School in Ahmedabad realised an issue of the huge waste generation in the school canteen. After studying the facts, understanding the causes, addressing the issue with the canteen owner and during assemblies, they came up with the solution of bringing breakfast from home and eating in self made or brought from home paper plates. Making this mandatory reduced waste drastically from about 500 to 25 plates at end of the first week only!

schools from 15 states. It has been well received by the regional and national media due to continuous events, activation and campaigns.

An online Essay Competition for children received 700 entries from seven states of India. The topic for the essay was 'If Mahatma Gandhi came to our current world, what attributes he would see in a Swachhagrahi?'

The 'Safai Ke Sitare' campaign is a creative and humble attempt to acknowledge & respect the people whose endless efforts keep schools & their surroundings clean. Under this campaign, over 400 students took selfies with the cleaning staff of their schools. The campaign was successful in

creating a deep sensitisation and understanding about each individual's role in the pursuit of cleanliness.

'Gandagi se Azadi' is yet another online campaign that identifies the issues falling under the Swachhagraha project and takes appropriate actions to correct them. The campaign has seen participation from over 60 schools of 10 states. Another campaign called 'Swachhagraha Ke Reporters' encouraged students to act as reporters and inquire about 'Who is responsible for cleanliness?' A total of 180 videos received from various places across India echoed the presence & acceptance of the Swachhagraha project.

At the end of the first year of implementation, the Adani Foundation has started awarding top Swachhagraha Schools, Preraks and students for the exemplary work done by them throughout the year.

It has been planned to launch Swachhagraha in 11 more states during 2017-2018.

Community at Large

Through social media engagement, the Swachhagraha project has reached out to over 8 lakh people. It has also reached to 30 lakh radio listeners in Ahmedabad city through an extensive campaign on Radio Mirchi in Ahmedabad for more than 70 days. As an acknowledgement of its unique behaviour changing communication, the project is also featured on the UNESCO green initiative website. The Commissioner of Rajkot Municipal Corporation invited the Swachhagraha team to create awareness and bring about a change in the public at large.

simultaneous street plays by 81 schools and awareness hoardings have been well received. The Vidyanagar Nature Club and local civic authorities had organised the Greenathon event where a pledge campaign was carried out. Swachhagraha was also featured in the Vibrant Gujarat Global Summit 2017 through venue branding at various places.

The Swachhagraha project highlights the citizens' responsibilities and duties towards a clean and green India. It is committed towards implementing a mass movement by creating a culture of cleanliness which will free our country from unhygienic and poor sanitation conditions.

Saksham - Making the Youth of India Capable

'Saksham', which translates to able and competent in English, is an ideology that the Adani Skill Development Centre (ASDC) abides by. It aims to help the youth of India in achieving their goals by turning them into skilled professionals. This ideology knows no limits when it comes to making world class skill development training available to the youth. ASDC, a nonprofit organisation, is the youngest among all the companies of the Adani Group. For many of its initiatives, ASDC partners with various Indian Government schemes, corporates and other organisations.

Adani Gas Limited is a pioneer in extending its support to ASDC. One of the initiatives of ASDC was to mobilise candidates from across Gujarat, who were trained in plumbing through government initiatives, under its Saksham Project. They were given gas technician training, a customised and specialised training on PNG connections to expand the City-based Gas Grid Network of Adani Gas Ltd. Supported by a stipend, all the candidates got placement-linked skill development training with on-the-job working opportunities, entirely supported by Adani Gas Ltd. Now, 23 of the trained candidates are working happily with Adani Gas Ltd. After its successful completion, this training is being extended to 8 different locations in India with the support of Adani Gas Ltd. and Indian Oil Adani Gas Pvt. Ltd.

To support more and more Indian youth in uplifting/improving their lives through skill development programmes, a good training centre needs to be set up. For this reason, Adani Power Maharashtra Limited and the Adani Foundation have supported ASDC in setting up a Skill Development Centre in Tirora. The centre was inaugurated on December 14, 2016 offering training in two trades: electrician and welding. The centre is equipped with state-of-the-art training facilities along with an augmented reality-based training simulator for welding. At Tirora, Saksham project will execute a placement linked training programme for 335 youths in 2017-18 with support from the Tribal Development Department of Maharashtra Government and a Private Placement Consulting Firm.

In another initiative, the Saksham project provided skill development training in operation of sewing machines to women of Surguja (Chhattisgarh), Kawai (Rajasthan), Dhamra (Odisha) & Godda (Jharkhand). The project has also provided placements, in other industries, to women who were already skilled. This initiative was aimed at social upliftment through women empowerment.



Along with Sewing Machine training, one more initiative, of the Saksham project was undertaken at Surguja, Chhattisgarh, where local students were trained on fitter trade. In all, at Surguja, 350 candidates were trained in various trades including 203 on the basic fitter and 128 on sewing machine operation. The placement ratio for fitter trade is 100%. For sewing machine operation, besides training, women were also given an opportunity to work from home and stitch uniforms of students of Adani Vidya Mandir, Bhadreshwar, Gujarat. In this way, the project ensured development of women in this area, while increasing their earning potential.

In Vizhinjam, Kerala, the initial task performed under the Saksham project, was studying the skill profile of the youth to understand the skill set requirement. The findings of this study recommended for a pedagogic approach in the skill

development programmes. Efforts were made to design three kinds of skilling programmes, namely employability skills, construction skills and livelihood/ entrepreneurship skills. Giving much desired importance to the programme, Hon'ble Minister of Ports, Shri. Ramachandran Kadannappalli, formally launched the Skill Development Programme at Vizhinjam on November 23, 2016. In all, 708 candidates have benefited through this programme in the past year.

The Government of Madhya Pradesh, through the State Urban Development Authority under the

National Urban Livelihood Mission, selected ASDC as one of its training partners to provide a placement linked training programme to 400 local youth on the technical trade of electrician.

ASDC has set a target of making 3,00,000 Indian youth 'Saksham' in various trades by 2022. For the same, ASDC has signed an MoU with the National Skill Development Corporation (NSDC) in the presence of the Hon'ble Prime Minister of India, Shri Narendra Modi, and Hon'ble Minister of State Skill Development & Entrepreneurship, Shri Rajiv Pratap Rudy, on December 19, 2016. ASDC has also signed another MoU, in the presence of Shri Rajiv Pratap Rudy, with the Government of Gujarat to establish two Skill Development Centres in Gujarat on January 12, 2017 during the 8th Vibrant Gujarat Global Summit 2017. ASDC is executing both these plans in a phase-wise manner. In the

> first phase, Skill Development Centres will be operational in Ahmedabad, Mundra & Surat in Gujarat, Tirora in Maharashtra, Surguja in Chhattisgarh, and Vizhinjam in Kerala. By 2017 these centres will be operational in Indore & Bhopal too.

To understand the extent of outreach of 'Saksham' let's state the statistics. The Adani Skill Development Centre has provided skill development training to 2,986 candidates in 2016-17 and has already mobilised over 1,000 candidates to be trained in the first quarter of 2017-18.

Udaan – Igniting young minds to dream big

Udaan is a special project inspired by the life-changing story of Mr. Gautam Adani, the Chairman of the Adani Group. As a child, Mr. Adani had visited the Kandla port in Gujarat, and after looking at the expanse of the port, he dreamt of having his own port one day. The rest, as they say, is history.

Project Udaan is a learning-based initiative focused on the youth of the nation. Under this project, a free-of-cost exposure tour is organised wherein students are given a chance to visit the Adani Port, Adani Power & Adani Wilmar facilities to get an insight into the large-scale business activities carried out there.
